EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT' BETWEEN BRAZIL AND THE IVORY COAST ON THE ABOLITION OF VISAS FOR HOLDERS OF DIPLOMATIC AND OFFICIAL PASSPORTS

I have the honour to inform you that the Government of the Republic of the Ivory Coast wishes to conclude with the Government of the Federative Republic of Brazil an agreement on the abolition of visas for holders of diplomatic and official passports, in the following terms:

- (1) Holders of valid Brazilian diplomatic or official passports shall be exempt from visa requirements for entering the Ivory Coast and remaining there for a period not exceeding three months;
- (2) Holders of valid Ivory Coast diplomatic and official passports shall be exempt from visa requirements for entering Brazil and remaining there for a period not exceeding three months:
- (3) The limitation laid down in paragraphs (1) and (2) shall not apply to personnel assigned to serve in the diplomatic missions and consular offices of the respective countries;
- (4) The abolition of visas, which is the subject of this Agreement, shall not exempt the holders of Brazilian and Ivory Coast diplomatic and official passports from complying with the laws and regulations in force concerning aliens entry into, sojourn in and departure from the respective countries;
- (5) This Agreement shall enter into force on the date of this exchange of notes and shall remain in force initially for one year. At the end of this period, if it has not been denounced, the Agreement shall be considered to have been extended for an indefinite period;
- (6) After the first one-year period, this Agreement may be denounced. However, the denunciation shall enter into force only 30 days after the other Party has been notified in writing.

If you are in agreement with the foregoing provisions, I have the honour to propose that this note and your reply should constitute an agreement on this subject between our two Governments.
