AGREEMENT 1 BETWEEN THE GOVERNMENT OF DEN-MARK AND THE GOVERNMENT OF INDIA ON THE ESTABLISHMENT OF AN ABATTOIR AT C.F.T.R.I., MY-SORE

Agreement between the Government of Denmark and the Government of India on the Establishment of an abattoir for training of personnel at the Central Food Technological Research Institute in Mysore, Mysore State.

The Government of Denmark and the Government of India, being desirous of strengthening the friendly relations between the two countries and their peoples, and recognizing their mutual interest in promoting their economic and technical development, particularly by providing means for education and training, have agreed as follows:

Article I. The objective of the technical and economic co-operation under this Agreement is to contribute to the modernization of slaughter-houses in India by establishing an abattoir for research and training in meat technology at the Central Food Technological Research Institute in Mysore, Mysore State, hereafter referred to as the CFTRI.

Article II. The purpose of establishing the abattoir will be to create a model for future construction of slaughter-houses in other cities in India, serving at the same time as a research and training facility for the CFTRI staff and for the staff from slaughter-houses in other cities in India.

The training abattoir will be placed under the administration of the CFTRI and supervised by the Indian Government authorities concerned.

Article III. The commitments of the Government of Denmark under this Agreement comprise:

- (a) provision of a detailed sketch lay-out, stating all special requirements regarding equipment, building materials, and services;
- (b) payment of all expenses in connection with three visits by an engineer from the projecting firm;
- (c) provision for the abattoir of equipment and spare parts to a maximum of 960,000 Danish Kroner. The equipment will be delivered c.i.f. nearest Indian port;
- (d) recruitment, payment of international travel expenses, salary and insurance for one Danish adviser for a period of six months to assist the CFTRI in running the abattoir;

- (e) fellowships of a duration of six months in Denmark, including travel expenses, for two Indian citizens employed at CFTRI.
- Article IV. The commitments of the Government of India under this Agreement comprise:
- (a) procurement of suitable site and building with all installations for the training abattoir, including all working expenses;
- (b) installation of machinery and equipment;
- (c) recruitment and payment of salaries for Indian staff members;
- (d) payment of all other expenses required for the establishment and operation of the project which are not listed above and not mentioned under the commitments of the Government of Denmark.
- Article V. Procedures will be set up by the Government of India whereby import duties and other fiscal charges, if any, on all the equipment including spare parts and materials for the training abattoir to be supplied by the Government of Denmark in pursuance of article III are not payable by the Government of Denmark.
- Article VI. The Government of India will provide a suitable residence for the expert to be sent out in pursuance of article III, and accord him such privileges as are normally accorded to comparable experts at technical cooperation projects under the rules and regulations of the General Agreement between the Government of Denmark and the Government of India concerning technical cooperation of February 16, 1970. ¹
- Article VII. The items provided by the Government of Denmark will become the property of the Government of India upon their arrival in Indian territory on the condition that they remain at the disposal of the expert during the period of his assignment and for the purpose thereof under the present Agreement.
- Article VIII. The Government of India will ensure that the equipment donated by the Government of Denmark, after the completion of the project, will continue to be used for the purpose, for which it was intented.
- Article IX. The present Agreement shall enter into force on the date of its signature and shall remain in force for a period of two years. The Agreement may be terminated at any time by either Party giving six months notice in writing to the other Party. The present Agreement may be amended by an exchange of letters between the two Governments.
