Texte authentique : anglais. Enregistré par le Danemark le 9 mars 1973. EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF KENYA CONCERNING THE IMPLEMENTATION OF THE PIG HUS-BANDRY EXTENSION PROJECT

Sir,

I have the honour to refer to the application of May 6, 1968, of the Government of Kenya, *ref.* EPD. 82/18/02, for Danish assistance regarding the implementation of the Pig Husbandry Extension Project.

The Government of Denmark agrees to co-operate with the Government of Kenya on the implementation of this Project in accordance with the general outlines of the Memorandum attached to the above-mentioned application on the understanding that:

The responsibility for the implementation of the project shall rest with the Animal Husbandry Division of the Ministry of Agriculture, Nairobi.

The Danish Pig Specialist to be in charge of the Project, as well as the Danish Pig Research Officer and the five Danish Pig Extension Specialists shall be recruited by the Government of Denmark, which will pay their salaries, insurances and travel costs to and from Kenya. The legal position of the Danish personnel shall be in accordance with the general terms for expatriate advisers in Kenya until an agreement between the Government of Denmark and the Government of Kenya on technical co-operation has been signed. Hereafter the legal position of the said personnel shall be in accordance with that agreement.

Any supplies, materials or equipment, including motor vehicles, imported into Kenya or bought in Kenya for the purpose of implementing the Project shall be exempted from import restrictions, customs duties and other fiscal charges.

The Danish Pig Extension Specialists and the Danish Research Officer shall report to the Project Leader regularly in order to ensure an efficient coordination of the extension work. The Project Leader shall report monthly in English to the respective Danish and Kenyan authorities on the progress of the Project.

The Danish Government will upon recommendation from the Project Leader:

- (a) contribute to improvements to pig demonstration facilities on Farmers Training Centres up to a total amount of K £ 2,000 (two thousand),
- (b) contribute to improvements in research facilities up to a total amount of K £ 500 (five hundred),
- (c) meet the initial costs of expanding piggeries at the Farmers Training Centres up to a total amount of K £ 3,000 (three thousand).

The Danish Government will for the use of the Danish experts provide one residence at Naivasha and one residence at one or two Farmers Training Centres where this is necessary. The cost of these houses must not surpass a total amount of K \pm 12,000 (twelve thousand). The Government of Kenya shall be responsible for the erection and the administration of the houses.

The use of the houses after expiry of the Project Agreement shall be subject to special agreement between the two Governments.

The Government of Kenya will provide accommodation for the remaining Danish staff on their respective posts. The Danish Government will for official use and within a total amount of K \pounds 5,600 (five thousand and six hundred) provide each of the Danish staff members with a motor vehicle. The motor vehicle shall become the property of the Government of Kenya upon the expiry of the Project Agreement. The Government of Kenya will meet the running costs of these vehicles. However, the Government of Denmark shall each year refund such expenses up to a total amount of K \pounds 200 (two hundred) per year.

The Government of Kenya will provide all necessary funds mentioned in item (c) "Government Counterpart" of the above mentioned memorandum as well as meet all other costs exceeding the Danish funds allocated for the above mentioned purposes.

Amendments or alterations to this exchange of notes may be made by mutual agreement between the Government of Denmark and the Government of Kenya and shall be confirmed by an exchange of letters.

The Agreement about the Pig Husbandry Extension Project shall be in force for four years after the date of the exchange of notes to that effect but may be terminated by each party by written notice given at least six months before the date of termination.

If the foregoing is acceptable to the Government of Kenya, I have the honour to suggest that this note and your reply to that effect be regarded as constituting an agreement between the Government of Denmark and the Government of Kenya concerning the implementation of the Pig Husbandry Extension Project.

Please accept, Sir, the assurance of my highest consideration.
