# PROTOCOL<sup>1</sup> RELATING TO THE INTERNATIONAL COMMISSION ON CIVIL STATUS

The High Contracting Parties,

Considering that, in an exchange of letters, Belgium, France, Luxembourg, the Netherlands and Switzerland have recognized the International Commission on Civil Status.

Considering that it would be useful to specify the procedures for the exchange of documentation prepared under the auspices of this Commission,

Have agreed as follows:

Article I. For the purposes of preparing and updating legislative documentation and documentation on judicial precedents relating to personal status law and to nationality, tasks which have been entrusted to the International Commission on Civil Status, the High Contracting Parties undertake to provide the said Commission free of charge with such information as it may require for its studies and work.

Article II. In order to consult the documentation assembled by the International Commission on Civil Status, the ministerial departments, diplomatic missions, consuls-general, consuls, vice-consuls or consular agents of each of the High Contracting Parties may correspond directly with the Secretary-General of the said Commission.

Article IV. The High Contracting Parties shall transmit to the competent authorities of their respective countries the necessary instructions for the implementation of this Agreement, which shall enter into force on 1 October 1950.

# ADDITIONAL PROTOCOL<sup>1</sup> TO THE PROTOCOL RELATING TO THE INTERNATIONAL COMMISSION ON CIVIL STATUS SIGNED AT BERNE ON 25 SEPTEMBER 1950<sup>2</sup>

The High Contracting Parties signatories to the Berne Protocol of 25 September 1950<sup>2</sup> concerning the International Commission on Civil Status,

Considering that, as a result of the expansion of the work of the Commission, provision should be made for the accession of new States,

Have agreed as follows:

Sole article. 1. States which are not signatories to the Berne Protocol of 25 September 1950 concerning the International Commission on Civil Status shall be eligible to accede to that Protocol.

- 2. Their applications for accession shall signify acceptance of the regulations of the Commission and a commitment to subscribe the amount of the contribution resulting from article III of the aforementioned Protocol and the rules laid down for its application. Applications shall be transmitted through the diplomatic channel to the Swiss Confederation and communicated by the latter to each of the signatory and acceding States and to the General Secretariat of the Commission.
- 3. Each new application must be approved by the General Assembly of the Commission without a single dissentient vote from the duly authorized delegates of the States parties to the Protocol of 25 September 1950. It shall take effect 30 days after the date of such approval and shall be communicated to each of the signatory and acceding States.
