AGREEMENT¹ BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA ON DANISH CONTRIBUTIONS TO THE REGIONAL DEVELOPMENT FUND

The Government of Denmark and the Government of the United Republic of Tanzania desiring to co-operate in furthering the economic and social development in Tanzania, have agreed as follows:

Article I. THE REGIONAL DEVELOPMENT FUND

The Tanzania Government has established the Regional Development Fund (hereinafter called the Fund) for the financing of development projects in rural areas.

The purpose, functions and administrative structure of the Fund are laid down in the Presidential Circular No. 1 of 1968.

Article II. DANISH CONTRIBUTION

To assist in the financing of small-scale development projects in rural areas in accordance with the Presidential Circular referred to in article I, the Danish Government shall, subject to the provisions set forth in this Agreement make available to the Tanzania Government a grant of 4.5 mill. Danish Kroner.

The grant will be transferred to the Tanzania Government in yearly instalments of 1.5 mill. Danish Kroner each. The transfers will take place in April 1973, 1974, and 1975.

Article III. OBLIGATIONS OF THE TANZANIA GOVERNMENT

1) The Tanzania Government shall furnish the Danish Government with all such information as the latter may reasonably request with regard to the Fund.

Especially the Tanzania Government undertakes to furnish the Danish Government with the following:

- a) By 1 August each year information on the Tanzania Government appropriations to the Fund for that financial year and the allocations to each region.
- b) (i) Semi-annual report within three months after the end of every six months on the activities financed by the Fund describing the types of projects, amounts allocated and status of implementation.

(ii) Annual financial statement on a regional basis within four months after the end of the financial year.

2) The Tanzania Government shall inform the Danish Government on any amendment to the Presidential Circular No. 1 of 1968 referred to in article I.

3) The Tanzania Government shall afford all reasonable opportunity for representatives of the Danish Government to visit sites of projects financed by the Fund.

Article IV. EFFECTIVE DATE; TERMINATION; AMENDMENTS; CONSULTATIONS

1) This Agreement shall enter into force upon signature and shall remain in force until the 31st May 1975 unless terminated by not less than six months' written notice by either of the two Governments. Such written notice shall not be served until consultations to that effect have taken place between the two Governments.

2) This Agreement may be amended by an exchange of letters between the two Governments.

3) The two Governments shall, at the request of either Government, consult on any matter concerning this Agreement.

Article V. DELEGATION OF COMPETENCE

Unless otherwise notified, the Danish International Development Agency (DANIDA) and the Ministry of Finance of the Tanzania Government shall be competent to represent their respective Governments for the purposes of this Agreement.

IN WITNESS WHEREOF the undersigned, being duly authorized thereto, have signed this Agreement.
