AGREEMENT¹ ON CO-OPERATION IN CIVIL AVIATION BETWEEN THE FRENCH REPUBLIC AND THE ISLAMIC REPUBLIC OF MAURITANIA

The Government of the French Republic, on the one hand, and

The Government of the Islamic Republic of Mauritania, on the other hand,

Desiring to ensure effective co-operation in civil aviation,

Have agreed as follows:

Article 1. In the interests of information and harmonization of their respective positions, the civil aviation administrations of the French Republic and the Islamic Republic of Mauritania shall co-ordinate their activities closely and shall exchange any information that may be useful to them. They shall consult each other before any international technical conference of common interest to them.

Article 2. At the request of the Islamic Republic of Mauritania, the French Republic shall give assistance in the training of technicians who may, *inter alia*, be admitted to specialized technical schools in the French Republic.

Article 3. At the request of the Islamic Republic of Mauritania, the French Republic shall assist it in studying and, if necessary, in implementing its civil aviation equipment programme.

Article 4. The French Republic and the Islamic Republic of Mauritania shall consult each other, as far as is necessary, for the purposes of harm-onizing their technical regulations in the field of civil aviation.

Article 5. Until such time as the Islamic Republic of Mauritania is able to organize its own search and rescue service, operations of this kind shall be carried out under the conditions in force at the date of signature of this Agreement.

Article 6. This Agreement shall enter into force at the same time as the Treaty on co-operation signed on this day.²

TERMINATION of the Agreement on co-operation in civil aviation between the French Republic and the Islamic Republic of Mauritania of 19 June 1961¹
