## AGREEMENT' BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH ON TECHNICAL ASSISTANCE IN THE FIELD OF FOOD TECHNOLOGY TRAINING

With reference to the General Agreement regarding technical assistance between Denmark and the People's Republic of Bangladesh signed on the 26th August, 1972, and in pursuance of the aims and objectives of that agreement, the Government of Denmark and the Government of the People's Republic of Bangladesh have agreed as follows:

Article I. With a view to improve the training facilities in the field of food technology the Government of Denmark and the Government of the People's Republic of Bangladesh will co-operate in establishing a Food Technology Section under the Chemical Technology Department of Dacca Polytechnic Institute for the purpose of training personnel to work in food industries and food catering enterprises by offering elective courses under chemical engineering diploma curriculum of the Institute. The details of elective courses and related matters shall be worked out as per regulations of the Bangladesh Board of Technical Education.

Article II. The commitments of the Government of Denmark under this Agreement are:

- (a) to recruit and provide
  - one expert in food technology training for six months during the preparatory stage of the Project,
  - one expert in food science disciplines for eighteen months, and
  - one expert in food technology disciplines for eighteen months:
- (b) to grant 4 two-year fellowships for studies at a food technology research institute outside Bangladesh to qualified Bangladesh nationals who shall work as teachers at Dacca Polytechnic Institute after the end of their fellowships; and
- (c) to supply equipment for three laboratories within an amount of Danish kroner 600,000 including freight and insurance.

Article III. The commitments of the Government of the People's Republic of Bangladesh under this Agreement are:

- (a) to recruit and pay the salaries, allowances, etc., of
  - three senior instructors in the fields of chemistry, food science and food technology,
  - three junior instructors in the same fields, and
  - the necessary laboratory and office personnel;
- (b) to provide working premises for the Food Technology Section at Dacca Polytechnic Institute;
- (c) to pay the recurring costs of the Food Technology Section at Dacca Polytechnic Institute;

- (d) to extend to the experts mentioned in article II (a) all the privileges enumerated in article IV of the General Agreement on technical assistance of August 26, 1972; and
- (e) to arrange for the import and transport of the laboratory equipment provided by the Government of Denmark under article II (c) of this Agreement in accordance with article V of the General Agreement on technical assistance of August 26, 1972.
- Article IV. Delivery and installation of the laboratory equipment mentioned in article II (c) and the service of the experts, fellowship-holders and personnel mentioned in articles II and III will take place in accordance with the terms of the Plan of Operation to be agreed upon by the two Parties.
- Article V. The equipment provided by the Government of Denmark in accordance with article II (c) shall upon its arrival in Bangladesh become the property of the Government of the People's Republic of Bangladesh.
- Article VI. The present Agreement shall enter into force on the date of its signature and shall remain in force until August 31, 1979. This Agreement may be terminated at any time by either Party giving six months' notice in writing to the other Party.

The present Agreement may be amended by exchange of letters between the Parties.
