# AGREEMENT<sup>1</sup> ON CULTURAL COOPERATION BETWEEN THE MONGOLIAN PEOPLE'S REPUBLIC AND THE REPUBLIC OF ITALY

Being guided by the high ideals of maintaining peace and friendship among nations and desirous of strengthening and furthering the friendly relations between the Mongolian and Italian peoples, and developing cultural cooperation between the two countries, the Government of the Mongolian People's Republic and the Government of Italy have entered into the following Agreement.

- Article 1. The Contracting Parties agree to encourage and facilitate cultural cooperation in an appropriate manner on the principles of mutual respect for each other's sovereignty and equality and non-interference in the internal affairs.
- Article 2. The Contracting Parties shall promote cultural cooperation between the two countries through exchange of information on the progress and achievements in the sphere of education, science, arts, literature, public health and sports and through exchanges of artistic and scientific workers, delegations as well as holding exhibitions and sending and receiving artists and sports groups.
- Article 3. The two Contracting Parties shall do their utmost to exchange teachers in the language of the other Party in literature, the arts, culture and history in the universities and institutes of the other Party at the request of either Party.
- Article 4. The Contracting Parties shall provide, under the Agreement or cultural cooperation plans to be signed between the two countries, scholarships for special and advanced training in various fields to be granted according to the national laws and regulations of the two Parties.
- Article 5. The Contracting Parties shall facilitate exchanges of radio and television programmes, national feature, documentary and short reels.
- Article 6. Pursuant to the present Agreement the Contracting Parties shall promote and encourage cooperation between the artistic, cultural, social, friendship and public organisations of the two countries.
- Article 7. In order to bring this Agreement into effect, the Contracting Parties shall instruct the authorities concerned in their respective countries to work out and implement a plan of operation for a specific period of time.
- Article 8. The Present Agreement is valid for five years, and it shall remain in force for consecutive periods of five years, provided that no notice of textual changes in full or in part is given by either Contracting Party three months before its expiry.
- Article 9. The present Agreement shall come into force 60 days after each Party shall have informed the other Party that all the requirements of the respective Constitutions have been met.

DONE in Rome on February 15, 1973 in Mongolian, Italian and in English. The three texts are equally authentic and in case of doubt the English text shall prevail.
