EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT' AMENDING THE CONVENTION OF 12 APRIL 1927² BETWEEN FRANCE AND NORWAY CONCERNING WINES AND SPIRITS

Ι

ROYAL EMBASSY OF NORWAY

Paris, 6 November 1974

Sir,

The entry into force of the new Norwegian legislation governing the advertising of alcoholic beverages affects certain provisions of the Convention concerning Wines and Spirits concluded between Norway and France on 12 April 1927².

I wish to make it clear that this legislative change arises exclusively out of considerations of social policy. Consumption of alcohol in Norway has increased greatly since 1965, and my Government has therefore decided to prohibit all advertising of alcoholic beverages, including beer.

These measures will not, of course, have any discriminatory effect in favour of Norwegian producers.

Accordingly, I have the honour to propose the two following amendments to the above-mentioned Convention:

- 1. Delete the second paragraph of article 1 (d).
- 2. Amend the first paragraph of article 2 (c) to read: "The representatives of French firms may only offer spirits to the Vinmonopolet Company".

If these proposals meet with the approval of your Government, I propose that the present letter and your reply shall constitute an Agreement which shall enter into force with effect from today.
