EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BE-TWEEN THE GOVERNMENT OF DENMARK AND THE GOV-ERNMENT OF TANZANIA CONCERNING DANISH FINANCIAL ASSISTANCE TOWARD CONSTRUCTION OF A COLLEGE OF NATIONAL EDUCATION AT MONDULI

Excellency,

I have the honour to refer to previous consultations concerning Danish financial assistance to construction of a College of National Education at Monduli.

The Government of Denmark is willing, during a period of 3 years, to make available a grant of 17 million Danish kroner for this construction work under the following general conditions:

1) The grant will be used for the construction of a College of National Education at Monduli near Arusha. The College will be used for training of grade A teachers.

2) The grant will be transferred in semi-annual instalments.

3) Immediately upon receipt of each transfer, a duly signed receipt voucher shall be forwarded to the Danish International Development Agency (DANIDA) in Copenhagen.

4) Each year by the 31st August, and when the grant has been fully utilized, a detailed statement of accounts accompanied by the appropriate building certificates must be established by the responsible project authorities.

These accounts shall be duly signed by a certified and independent auditor as well as by the Treasury and forwarded to DANIDA.

5) If the allocated funds are not totally utilized for the stipulated purposes, the balance must be retransferred to DANIDA together with the forwarding of the above-mentioned final accounts.

6) If the total accounts of the project in question exceed the allocated 17 million Danish kroner, the balance shall be covered by the Tanzanian authorities.

7) Every six months a progress report of the project shall be compiled and forwarded to DANIDA.

8) Tendering for the building contract shall be open to qualified East African contractors as well as to contractors outside East Africa interested in tendering.

The firm to whom the contract is awarded shall be given reasonable opportunity to remit profits to its country of residence and to pay for necessary imports in foreign currency.

If the foregoing proposal is acceptable to the Government of Tanzania, I have the honour to suggest that this note and your reply to that effect shall constitute an Agreement between our two Governments to enter into force on the date of your note in reply.
