EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE UNITED STATES OF AMERICA AND IRAN RELATING TO PRIVILEGES AND IMMUNITIES FOR AMERICAN TECHNICIANS ASSISTING IN MODERNIZATION PROGRAM OF IRANIAN ARMED FORCES

Excellency:

I have the honor to announce that the first contingent of American military and non-military technicians requested by your Government to assist in the modernization program of the Imperial Iranian Armed Forces has arrived in Iran. During recent weeks there have been discussions between representatives of the Ministry of War of the Imperial Government of Iran and the staff of this Mission concerning the detailed arrangements under which the technicians are to be assigned to Iran. It is the understanding of my Government that, in accordance with Iranian law and agreements in force between the Government of Iran and the Government of the United States, these personnel will be accorded the privileges and immunities specified in the Note of the Imperial Ministry of Foreign Affairs No. 9762 of December 9, 1964, and the Note of this Embassy No. 282 of the same date.²

I would appreciate your confirmation that this is also the understanding of the Imperial Government of Iran.

Please accept, Excellency, the assurances of my highest consideration.
