Your Excellency,

I have the honour to propose, on behalf of the European Space Research Organisation, that in accordance with Article 30 of the Protocol on Privileges and Immunities of the Organisation² the following Agreement, complementing the Protocol, be concluded between the Government of Sweden and the European Space Research Organisation.

- 1. For the purposes of Article 14 of the Protocol, the term "representatives of Member States" means the representatives and alternate representatives of Member States attending meetings of the Council of the Organisation and of its subordinate bodies.
- 2. The Chairman and the Vice-Chairmen of the Council, the Chairmen of the subordinate bodies of the Council and the members of the Audit Commission shall, if they cease to act as national representatives, remain covered by the provisions of Article 14 of the Protocol.
- 3. In application of Article 15 of the Protocol, the Director General of the Organisation and the official referred to in paragraph 1 (c) of Article XI of the Convention for the Establishment of the Organisation's shall, while discharging official functions in Sweden, enjoy the privileges and immunities to which a diplomatic agent is entitled under the provisions of the Vienna Convention on diplomatic relations.
- 4. Swedish citizens shall not in Sweden be entitled to the privileges and immunities referred to in Article 14, 15, 16 (b) and (e), and 17 (c) of the Protocol.

If the foregoing proposal is acceptable to the Government of Sweden, I have the honour to suggest that the present letter and your Excellency's reply should be regarded as constituting the Agreement reached between the Government of Sweden and the European Space Research Organisation in this matter.
