- 1. With reference to Mr. O. P. Kohli's letter No. F 19/40 70/IA of 11th April 1975 I have the honour to propose that the following provisions shall govern the delivery of a linear accelerator to the Cancer Institute, Madras, as part of Danish development assistance to India:
- 2. The Government of Denmark will purchase and deliver c.i.f. Madras a 4 megavolts linear accelerator, model Ulinac 4, produced at the Varian plants, California, U.S.A., as a gift to the Cancer Institute, Madras, and make available expert assistance for the erection of the equipment.
 - 3. The Danish grant is subject to the following conditions:
- that necessary import licences in respect of the accelerator (also spare parts included in the gift) will be granted;
- that—in case customs duty is payable—the necessary funds for this purpose will be provided by the Indian side;
- that provision for the necessary rooms, screening, installations, etc. will be made by the Indian side:
- that all necessary drawings, licences and clearances in respect of the accelerator's erection will be supplied by the Indian side; and
- that all necessary no-objection certificates will be granted the specialists who are to come to India to erect the accelerator, and, possibly, demonstrate its use to members of the staff of the Cancer Institute.
- 4. If the foregoing provisions are acceptable to the Government of India, I have the honour to propose that this letter and your reply to it constitute an agreement between our two Governments on this matter.
