AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF PAKISTAN AND THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY CONCERNING FINAN-CIAL ASSISTANCE

The Government of the Islamic Republic of Pakistan and the Government of the Federal Republic of Germany,

In the spirit of the friendly relations existing between the Islamic Republic of Pakistan and the Federal Republic of Germany,

Desiring to strengthen and intensify those friendly relations by fruitful co-operation in the field of development assistance,

Aware that the maintenance of those relations constitutes the basis of the present Agreement,

Wishing to supplement the aid which the Government of the Islamic Republic of Pakistan has hitherto received from the Government of the Federal Republic of Germany,

Intending to contribute to economic and social development in the Islamic Republic of Pakistan,

Have agreed as follows:

- Article 1. (1) The Government of the Federal Republic of Germany shall enable the Government of the Islamic Republic of Pakistan or other borrowers to be jointly selected by the two Governments to raise with the Kreditanstalt für Wiederaufbau (Development Loan Corporation), Frankfurt/Main, loans up to 90,000,000 DM (ninety million German Marks).
- (2) The loans referred to in paragraph 1 above shall be used as provided for in paragraphs 3 and 4 below.
- (3) Up to 40,000,000 DM (forty million German Marks) shall be used for projects to be jointly selected by the two Governments, provided that such projects have been found eligible for promotion.
- (4) Up to 50,000,000 DM (fifty million German Marks) shall be used to finance the foreign exchange costs arising from the purchase of supplies and services to cover Pakistan's current civilian requirements (commodity aid).

These supplies and services must be such as are covered by the list annexed to the present Agreement and for which import and foreign exchange licences have been issued after the entry into force of the relevant loan agreement to be concluded pursuant to article 2 of the present Agreement.

- (5) When using the aforesaid amount, sympathetic consideration shall be given to the requirements of enterprises established in Pakistan with German participation. The Government of the Federal Republic of Germany understands that the Government of the Islamic Republic of Pakistan will use the Rupee counterpart funds accruing from the sale of the loaned German Marks for development projects.
- Article 2. (1) The loans shall bear interest at the rate of 2 per cent per annum. They shall have a maturity of thirty years including ten years' grace.

- (2) The details of utilization as well as the other terms and conditions on which the individual loans will be granted shall be governed by the provisions of the agreements to be concluded between the borrowers and the Kreditanstalt für Wiederaufbau, which shall be subject to the laws and regulations applicable in the Federal Republic of Germany.
- Article 3. The Government of the Islamic Republic of Pakistan, to the extent that it is not itself the borrower, shall guarantee to the Kreditanstalt für Wiederaufbau all payments in German Marks to be made in fulfilment of borrowers' liabilities under the agreements to be concluded pursuant to article 2 (2) of the present Agreement.
- Article 4. The Government of the Islamic Republic of Pakistan shall exempt the Kreditanstalt für Wiederaufbau from all taxes and other public charges levied in the Islamic Republic of Pakistan at the time of the conclusion, or during the implementation, of the agreements referred to in article 2 (2) of the present Agreement.
- Article 5. The Government of the Islamic Republic of Pakistan shall allow passengers and suppliers free choice of transport enterprises for such transportation by sea or air of persons and goods are results from the granting of the loans, abstain from taking any measures that might exclude or impair the fair and equal participation of transport enterprises having their place of business in the German area of application of the present Agreement, and grant permits for such participation as required.
- Article 6. Supplies and services for projects financed from the loans shall, unless otherwise provided for in individual cases, be subject to international public tender.
- Article 7. With regard to supplies resulting from the granting of the loans, the Government of the Federal Republic of Germany attaches particular importance to preference being given to products of industries of Land Berlin.
- Article 8. With the exception of those provisions of article 5 which refer to air transport, this Agreement shall also apply to Land Berlin, provided that the Government of the Federal Republic of Germany does not make a contrary declaration to the Government of the Islamic Republic of Pakistan within three months of the date of entry into force of this Agreement.
- Article 9. The present Agreement shall enter into force on the date of signature thereof.

Done at Bonn on December 5, 1975, in duplicate in the English and German languages, both texts being authentic.

## ANNEX

- TO THE AGREEMENT OF DECEMBER 5, 1975, BETWEEN THE GOVERNMENT OF THE ISLAMIC REPUB-LIC OF PAKISTAN AND THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY CONCERN-ING FINANCIAL ASSISTANCE
- 1. List of goods and services eligible for financing from the loans up to a total value of 50,000,000 DM (fifty million German Marks) under article 1 (4) of the Agreement of December 5, 1975:
- (a) industrial raw and auxiliary materials as well as semi-manufactures;
- (b) industrial equipment:
- (c) spare parts and accessories of all kinds;
- (d) chemical products, in particular fertilizers, plant protection agents, pesticides, medicaments;
- (e) agricultural machinery and implements;
- (f) other industrial products important for Pakistan's development;
- (g) the costs, also in local currency, of transport, insurance and assembly arising in connexion with the importation of goods financed under the present Agreement;
- (h) consulting services and licensing fees.
- 2. Imports in accordance with the above list should comprise the greatest possible variety of goods. Imports not included in the above list may only be financed with the prior approval of the Government of the Federal Republic of Germany.

The importation of consumer goods for personal needs, especially luxury goods, as well as any goods and facilities serving military purposes, may not be financed from the loans.
