## PROTOCOL' ON ECONOMIC, INDUSTRIAL, SCIENTIFIC AND TECHNICAL CO-OPERATION BETWEEN DENMARK AND IRAN

The Government of Denmark and the Government of Iran,

desirous of further strengthening the friendly relations between the two countries.

confirming their interest in supporting and facilitating the continued development of economic, industrial, scientific and technical co-operation between the two countries to their mutual advantage,

recognizing the great significance of such co-operation and desiring to create the most appropriate conditions for its development with due regard to the comparative advantage of both nations as well as the realities of the changing pattern of the world economic situation,

have agreed as follows:

- Article 1. The two Parties shall encourage and develop the economic, industrial, scientific and technical co-operation between the two countries.
- Article 2. The two Parties recognize that possibilities for co-operation should be explored and utilized i.a. in the following fields:
- a) co-operation between institutions and enterprises in the two countries on projects of common interest, including joint ventures, license and know-how arrangements in the two countries as well as in the third markets, also including the export of products of joint ventures to third countries,
- b) studies and visits, with a view to the implementation of common projects,
- c) arranging of courses and conferences,
- d) exchange of specialists and trainees,
- e) exchange of technical documentation and information.
- Article 3. The conditions governing particular projects of economic, industrial, scientific and technological co-operation shall be agreed between the respective organisations, enterprises and firms of the two countries, in accordance with the laws and regulations in force in the two countries.
- Article 4. The two Parties establish a Joint Commission, at the level of under-secretary, on economic, industrial, scientific and technical co-operation composed of representatives of the two countries.

The Joint Commission shall:

- supervise the implementation of this protocol,
- explore the fields in which they consider the broadening of co-operation to be useful,
- consider proposals presented by either side, aimed at supporting and developing the economic, industrial, scientific and technical co-operation between the two countries.

 make recommendations for measures to be taken for the successful implementation of the protocol.

At the request of either Party the Commission shall meet alternately in Denmark and Iran.

Article 5. This protocol shall enter into force on the date of signature. It remains in force as long as it is not terminated by one of the two Parties with a notice of six months. Any such termination shall have no effect on the fulfilment of contracts and arrangements made under the provisions of the present protocol.
