EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF BANGLADESH CONCERNING A DANISH GRANT OF SOYBEAN OIL TO BANGLADESH

I

Dacca, November 14, 1975

Sir,

With reference to previous discussions and correspondence regarding a grant of crude soyabean oil by the Government of Denmark to the Government of the People's Republic of Bangladesh, I have the honour to propose that the following provisions shall govern the transfer of the grant:

I. Subject to the following provisions and such other provisions as may be agreed upon between the parties, the Government of Denmark shall make available to the Government of the People's Republic of Bangladesh a grant of crude soyabean oil to a value of 5 million Danish Kroner.

II. The specifications of the consignment are mentioned in the attached enclosure.

III. The Danish International Development Agency will purchase the soyabean oil and deliver the same CIF at Chittagong and/or Chalna port. The consignment will be addressed to:

At least one month prior to the arrival of the goods the Danish International Development Agency will forward the sets of non-negotiable shipping documents including insurance certificates to:

Negotiable shipping documents shall be sent to Sonali Bank Dacca.

IV. The Ministry of Food and Civil Supplies will undertake all expenses involved in the clearance of the goods and their transport inside Bangladesh. It will also make arrangement for the prompt delivery and distribution of the goods.

The Ministry of Food and Civil Supplies furthermore undertakes to pay any surcharge imposed on the shipper on account of demurrage exceeding seven days from the ship's arrival at the port of destination.

V. At the completion of the distribution, the Ministry of Food and Civil Supplies will submit a report to the Danish International Development Agency regarding the utilization of the grant supplied by the Government of Denmark.

If the foregoing provisions are acceptable to the Government of the People's Republic of Bangladesh, I have the honour to suggest that this letter and Your reply to it constitute an Agreement between our two Governments on this matter.
