EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF KENYA CONCERNING DANISH ASSISTANCE TO MURANG'A COLLEGE OF TECHNOLOGY

Sir,

I have the honour to refer to the Agreed Minutes of the annual development co-operation consultations between Kenya and Denmark of March 11, 1976, and to your Ministry's letters of March 2nd, 1976, ref. DV 88/79/01, and of March 28, 1974 ref. EPD/SA 82/18/02, regarding Danish assistance to Murang'a College of Technology, and to inform you that the Government of Denmark is willing to recruit and finance three Experts to be posted to the Murang'a College of Technology for a period of two years.

The financing of the staff is made with the following understanding:

- 1. The status of the expatriate staff shall be in accordance with the agreement of February 25, 1971,² between the Government of Denmark and the Government of Kenya on technical co-operation between Denmark and Kenya.
- 2. By way of annual reports DANIDA shall be kept informed of the activities of the College, its situation from an educational and economic point of view, as long as the Danish Staff covered by this letter is seconded to the College. Such reports, which may be made for each of the College's Financial Years, should be received by DANIDA not later than 3 months after the expiry of each period.

If the foregoing is acceptable to the Government of Kenya, I have the honour to suggest that your reply to that effect and this Note be regarded as constituting the agreement between the Government of Denmark and the Government of Kenya concerning Danish assistance to Murang'a College of Technology. The agreement shall enter into force on September 1st, 1976, and remain in force for two years.
