## AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN AND THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY CONCERNING FINANCIAL CO-OPERATION

The Government of the Hashemite Kingdom of Jordan and the Government of the Federal Republic of Germany,

In the spirit of the friendly relations existing between the Hashemite Kingdom of Jordan and the Federal Republic of Germany,

Desiring to strengthen and intensify those friendly relations by fruitful co-operation in the field of financial co-operation,

Aware that the maintenance of those relations constitutes the basis of the present Agreement,

Intending to contribute to economic and social development in the Hashemite Kingdom of Jordan,

Have, with reference to the negotiations held between their two Governments in Bonn on 17 July 1974, agreed as follows:

*Article 1.* (1) The Government of the Federal Republic of Germany shall enable the Government of the Hashemite Kingdom of Jordan or another borrower to be jointly selected by the two Governments to raise with the *Kreditanstalt für Wiederaufbau* (Development Loan Corporation), Frankfurt/Main, loans up to DM 10,000,000 (ten million German Marks) for the housing programme in the Jordan Valley if, after examination, it has been found eligible for promotion.

(2) Of the amount referred to in paragraph 1 above an initial loan of up to DM 1,000,000 (one million German Marks) shall be granted.

When positive results concerning the programme phase financed from this loan are available, further loans up to a total of DM 9,000,000 (nine million German Marks) shall be granted in agreement between the two Governments for the financing of further phases of the housing programme in the Jordan Valley.

*Article 2.* (1) The utilization of the loans as well as the terms and conditions on which they are granted shall be governed by the provisions of the agreements to be concluded between the borrower and the *Kreditanstalt für Wiederaufbau*, which shall be subject to the laws and regulations applicable in the Federal Republic of Germany.

(2) The Government of the Hashemite Kingdom of Jordan, to the extent that it is not itself the borrower, shall guarantee to the *Kreditanstalt für Wiederaufbau* all payments in German Marks to be made in fulfilment of the borrower's liabilities under the agreements to be concluded pursuant to paragraph 1 above.

*Article 3.* The Government of the Hashemite Kingdom of Jordan shall exempt the *Kreditanstalt für Wiederaufbau* from all taxes and other public charges levied in the Hashemite Kingdom of Jordan at the time of the conclusion, or during the implementation of the agreements referred to in article 2 of the present Agreement.

*Article 4.* The Government of the Hashemite Kingdom of Jordan shall allow passengers and suppliers free choice of transport enterprises for such transportation by land, sea or air of persons and goods as results from the granting of the loans, abstain from taking any measures that might exclude or impair the participation on equal terms of transport enterprises having their place of business in the German area of application of the present Agreement, and grant the relevant permits as required for the participation of such enterprises.

*Article 5.* Supplies and services for projects financed from the loans shall, unless otherwise provided for in individual cases, be subject to international public tender.

*Article 6.* With regard to supplies resulting from the granting of the loans, the Government of the Federal Republic of Germany attaches particular importance to preference being given to products of industries of Land Berlin.

*Article 7.* With the exception of those provisions of article 4 which refer to air transport, this Agreement shall also apply to Land Berlin, provided that the Government of the Federal Republic of Germany does not make a contrary declaration to the Government of the Hashemite Kingdom of Jordan within three months of the date of entry into force of this Agreement.

*Article 8.* The present Agreement shall enter into force on the date of signature thereof.
