EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE UNITED STATES OF AMERICA AND GREECE CONCERNING ATOMIC ENERGY: CONTINUATION OF SAFEGUARDS AND GUARANTEE PROVISIONS

I

The Ministry of Foreign Affairs present their compliments to the Embassy of the United States of America and have the honor to refer to the request by the Government of Greece for the assistance of the International Atomic Energy Agency in obtaining from the United States approximately 7000 grams of uranium enriched to approximately 90 percent in the isotope uranium 235. The transfer will take place under the terms and conditions in the Agreement for Cooperation in the Civil Uses of Atomic Energy between the United States and the IAEA,³ which entered into force on August 7, 1959, as amended on February 12, 1974.⁴ The material will be used at the Democritus Nuclear Research Center in the Research Reactor GRR-1, which was transferred to Greece under the Agreement for Cooperation Concerning Civil Uses of Atomic Energy Between the United States and Greece, of August 4, 1955,⁵ as amended on June 11, 1960,⁶ April 3, 1962,⁷ June 22, 1962,⁸ June 8, 1964,⁹ and September 27, 1968.¹⁰

In its Note number 6327/46/AS1097, dated July 16, 1974, the Government of Greece stated its appreciation of the continuing effect of the safeguards and guarantee provisions of the 1955 Agreement for Cooperation between the United States and Greece, as amended, which expired by its terms on August 3, 1974. The Government of Greece now agrees that the 7000 grams of uranium enriched to approximately 90 percent in the isotope U-235 requested from the United States for the GRR-1 Reactor will be held subject to the terms and conditions of Articles II, VI and VII of the expired 1955 Agreement for Cooperation between the United States and Greece, as amended.

The Government of Greece wishes to confirm to the Government of the United States its understanding that pursuant to the undertaking in the previous paragraph, no material used or produced in the GRR-1 Reactor will be used for atomic weapons or other nuclear explosive devices, for research or development of atomic weapons or other nuclear explosive devices, or for any other military purpose.
