EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF BANGLADESH CONCERNING A GRANT OF RAW RUBBER BY THE GOVERNMENT OF DENMARK TO THE GOVERNMENT OF BANGLADESH

Dacca, July 20 1976

Sir,

With reference to previous discussions and correspondence regarding a grant of raw rubber by the Government of Denmark to the Government of Bangladesh I have the honour to propose that the following provisions shall govern the transfer of the grant:

I. Subject to the following provisions and such other provisions as may be agreed upon between the parties, the Government of Denmark shall within the sum of Dkr. 1,850,000 make available to the Government of Bangladesh a grant of up to 300 tonnes of raw rubber.

II. The specifications of the consignment are mentioned in the attached enclosure.

III. The Danish International Development Agency will purchase the rubber and deliver the same CIF at Chittagong. The consignment will be addressed to:

Bangladesh Chemical Industries Corporation Shilpa Bhaban, Motijheel Commercial Area Dacca

At least one month prior to the arrival of the goods the Danish International Development Agency will forward sets of non-negotiable shipping documents including insurance certificates to:

- i) The General Manager (Purchase) Bangladesh Chemical Industries Corporation 43, Dilkusna Commercial Area Dacca, Bangladesh
- ii) The Chief Finance Officer Bangladesh Chemical Industries Corporation Dacca, Bangladesh
- iii) The Manager, BCIC Branch Office 107, Agrabad Commercial Area Chittagong, Bangladesh
- iv) The Insurance Officer Bangladesh Chemical Industries Corporation Dacca, Bangladesh

Negotiable shipping documents shall be sent to Sonali Bank, Dacca.

IV. The Ministry of Industries/Bangladesh Chemical Industries Corporation, Dacca, will undertake all expenses involved in the clearance of the goods and their transport inside

Bangladesh. It will also make arrangements for the prompt delivery and distribution of the goods.

V. At the completion of the distribution, the Ministry of Industries/Bangladesh Chemical Industries Corporation, Dacca, will submit a report to the Danish International Development Agency regarding the utilization of the Danish Grant.

If the foregoing provisions are acceptable to the Government of Bangladesh, I have the honour to suggest that this letter and your reply to it shall constitute an agreement between our two Governments on this matter.
