UNITED STATES AGENCY FOR INTERNATIONAL DEVELOPMENT AMMAN, JORDAN

WAIVER

Under the authority provided by AID Handbook 19 Chapter 1D3 I hereby waive for a period of six months the initiation of PIO/Ps in the amount of one million dollars. This waiver is granted in order to permit the development of the program as agreed upon by the GOJ. The disturbance in Lebanon and the evacuation of AUB students have disrupted their educational program which has undesirable consequences on the developmental efforts of Jordan. AID/W responded favourably to this situation and agreed to offer alternative training at U.S. or appropriate third country teaching in English Institutions. Although negotiations with the GOJ have resulted in specific basis for selection of participants to be reprogrammed yet not all of the official transcripts from AUB have been received.

We anticipate issuance of the PIO/P documents within six months from the date of this waiver.
