AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE UNITED STATES OF AMERICA AND THE GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA FOR THE SALE OF AGRICULTURAL COMMODITIES UNDER THE PUBLIC LAW 480, TITLE I, PROGRAM

The Government of the United States and the Government of the United Republic of Tanzania agree to the sales of agricultural commodities specified below. This Agreement shall consist of the preamble, parts I and III of the Title I Agreement signed June 15, 1976,² together with the following part II:

PART II. PARTICULAR PROVISIONS

Item I. COMMODITY TABLE

Item II. PAYMENT TERMS

Convertible Local Currency Credit:

1. Initial payment, 5 percent;
2. Currency use payment, none;
3. Number of installment payments, 31;
4. Amount of each installment payment, approximately equal annual amounts;
5. Due date of first installment payment, 10 years from date of last delivery of commodities in each calendar year;
6. Initial interest rate, 2 percent;
7. Continuing interest rate, 3 percent.

Item III. USUAL MARKETING TABLE

Item IV. EXPORT LIMITATIONS

A. The export limitation period shall be U.S. fiscal year 1977 or any subsequent U.S. fiscal year during which commodities financed under this Agreement are being imported or utilized.

B. For the purpose of part I, article III (A) (4), of the Agreement, the commodities which may not be exported are: for rice, rice in the form of paddy, brown or milled; for corn/grain sorghums, corn, grain sorghums, barley, oats, and rye including mixed feed containing such grains.

Item V. SELF-HELP MEASURES

A. In implementing these self-help measures, specific emphasis will be placed on contributing directly to development progress in poor rural areas and on enabling the poor to participate actively in increasing agricultural production through small-farm agriculture.

B. The Government of the United Republic of Tanzania agrees to:

1. Expand its program of assistance to farmers through improving the system for distributing seed and fertilizers;
2. Improve and expand the agricultural educational programs now being undertaken at the vocational agricultural schools;
3. Enlarge its agriculture research program especially in the area of basic grains;
4. Improve and expand the system of farm to market roads, especially in those areas that are isolated during the rainy season;
5. Expand the program of animal disease control by bringing animal health measures to a larger proportion of the livestock;
6. Make available more credit to farmers to enable them to purchase inputs necessary to expand production;
7. Develop a system of price supports designed to economize agricultural production of domestic food crops;
8. Promote export crops in those areas most suited to their production and develop a system for improving production and marketing;
9. Encourage the production of a greater amount of fresh fruits and vegetables, especially for home consumption;
10. Expand and improve food storage and distribution facilities;
11. Improve and expand facilities for collecting, analyzing and disseminating agricultural and related data.

Item VI. ECONOMIC DEVELOPMENT PURPOSES FOR WHICH PROCEEDS ACCRUING TO IMPORTING COUNTRY ARE TO BE USED

A. The proceeds accruing to the importing country from the sale of commodities financed under this Agreement will be used for financing the self-help measures set forth in the Agreement and for the following economic development sectors: agriculture.

B. In the use of proceeds for these purposes, emphasis will be placed on directly improving the lives of the poorest of the recipient country's people and their capacity to participate in the development of their country.

This Agreement shall enter into force upon signature.

IN WITNESS WHEREOF, the respective representatives, duly authorized for the purpose, have signed the present Agreement.
