Dear Mr. Assistant Attorney General,

I have the honour to refer to the Agreement on Procedures for Mutual Assistance between Law Enforcement Agencies of the United States and Pakistan, signed in Washington on 9th September 1977² in connection with matters relating to the Lockheed Aircraft Corporation and The Boeing Company. In accordance with the provisions of paragraph 13 of the aforementioned Agreement, the Ministry of Interior, Government of Pakistan, requests that the operation of the Agreement be extended to include alleged illicit acts pertaining to the sales activities in Pakistan of the McDonnell Douglas Corporation and its subsidiaries and affiliates.

2. The Ministry of Interior, Government of Pakistan, undertakes to exchange information relating to the McDonnell Douglas Corporation under the same terms and conditions as those contained in the aforementioned Agreement.
