VETERINARY HEALTH AGREEMENT BETWEEN THE GOVERN-MENT OF THE KINGDOM OF SPAIN AND THE GOVERN-MENT OF THE HUNGARIAN PEOPLE'S REPUBLIC

The Government of the Kingdom of Spain and the Government of the Hungarian People's Republic,

With a view to facilitating trade in animals, animal products and products intended for animals, and safeguarding their respective territories from the accidental introduction of infectious, contagious or parasitic diseases of domestic animals or of zoonoses, and

With a view to establishing bilateral co-operation in veterinary science and practice,

Have decided to conclude this Agreement.

Article 1. This Agreement establishes the veterinary health requirements that shall govern imports of live animals, animal products and products intended for animals, originating in the territory of one of the Contracting Parties and going to the territory of the other.

Article 2. The preceding paragraph shall apply to the following live animals, animal products or products intended for animals:

- (a) The term "live animals" shall include:
 - Domestic and wild Equidae (horses, donkeys, mules, hinnies, etc.);
 - Domestic and wild cloven-hoofed animals (cattle, buffalo, camels, sheep, goats, deer, pigs, etc.);
 - Domestic and wild rodents:
 - Domestic and wild carnivores:
 - Game birds (pheasants, partridges, capercaillies, etc.);
 - Domestic and wild fowl (chickens, turkeys, geese, ducks, guinea hens, etc.);
 - --- Bees:
 - Fish, fish roe, turtles, and the like.
- (b) The term "products of animal origin" shall include:
 - Food products of animal origin:
 - Meat, by-products and offal of cattle, Equidae, pigs, sheep, goats, rabbits, fowl, etc. (either frozen or preserved by some other authorized method);
 - Products processed from meat or edible offal of cattle, pigs, sheep, goats, domestic fowl, etc.;
 - Eggs, egg products, milk, milk products, honey;

- Non-edible products of animal origin; parts of animal carcasses intended for industrial processing or for animal feed:
 Lungs, feathers, horns, hoofs, heads, intestines, hair, hides and skins in general;
 Sperm;
- Products of animal origin for feeding animals or raw materials for compounding livestock feeds, and other products intended for animals.

Live animals and products of animal origin not specified in this Agreement shall be subject to the existing regulations of each Contracting Party.

Article 3. Live animals for foreign trade intended for slaughter must have been born in the country of origin.

Similarly, refrigerated or frozen meat for foreign trade must come from animals born in the country of origin.

- Article 4. The customs offices authorized to carry out veterinary health control of animals and products of animal origin, in accordance with the provisions of this Agreement, shall be designated by each of the countries concerned within two months from the signature of the Agreement, and the said control shall be carried out by the official veterinary services.
- Article 5. The following documents shall be required for the import, export or transit of live animals or products of animal origin:
- In the case of animals:
 - (a) An official veterinary certificate of origin and health.
- In the case of products of animal origin:
 - (a) An official veterinary certificate attesting to the products' origin and fitness for consumption and to the fact that they do not contain prohibited additives or other substances dangerous to the health of the consumer;
 - (b) A certificate containing the results of the laboratory analyses of each product, in accordance with veterinary health regulations.

These documents shall be issued by an official veterinarian on the forms required by the central veterinary services and shall be drawn up, in Spanish and Hungarian, in conformity with the applicable model in the annexes.

Article 6. Veterinary certificates of origin and health accompanying live animals for export shall indicate: the description, origin, destination and health data of the animals.

If the importing country considers that, owing to special circumstances, further supplementary data are required, it shall so inform the exporting country so that they may be included in the certificate.

Veterinary certificates of origin and health shall be valid for 10 days from the date of issue. If that period elapses before the livestock reaches the customs office of the exporting country, the offical veterinarian may extend it for a further 10 days, provided that the animals do not exhibit, on a second examination, any symptom of contagious disease. The results of such supplementary examinations shall be included in the veterinary certificate.

Individual veterinary certificates shall be issued for cattle, sheep, goats, Equidae and pigs for breeding.

Collective veterinary certificates shall be issued for cattle, Equidae, smaller livestock and fowl for slaughter, provided that the animals are of the same species, come from the same farm, are transported in the same vehicles and have the same destination.

All animals shall be duly identified by appropriate markings which shall be indicated in the certificate.

Article 7. Equidae, regardless of their destination, shall be accompanied by a certificate of origin and health conforming to the model in annex I.

This certificate may be collective for animals intended for slaughter; such animals shall be identified by an earmark or other device bearing the first three letters of the State of origin (Hungary or Spain) and the specific number of each animal.

The nature of the identifying device shall be indicated in the certificate, there being no need for individual descriptions of the animals.

Article 8. Cattle, sheep, goats and pigs for raising or breeding shall be accompanied by certificates of origin and health conforming to the relevant models in annexes II to IV.

The certificates shall be individual and shall contain a description of the marking used, which may be either a tattoo or a numbered tag attached to the ear.

Article 9. Cattle, sheep, goats and pigs for slaughter shall be accompanied by collective certificates of origin and health, as drawn up and approved by the Contracting Parties in annexes V and VI.

These animals shall be marked as provided in article 7 and the nature of the marking shall be indicated in the certificate.

Article 10. Wild, tame or domesticated animals intended for zoological gardens or the like shall be accompanied during transport by a certificate of origin and health issued by an official veterinarian and conforming to the model in annex VII.

Independently of the conditions set out in the certificate of origin and health, the importing country may prescribe other preventive measures that are advisable because of epizootic problems.

- Article 11. Eggs for hatching, day-old chicks and adult fowl shall be accompanied by a veterinary certificate of origin and health conforming to the model drawn up and approved by the Contracting Parties in annex VIII.
- Article 12. Dogs and cats for export shall be accompanied by a certificate of origin and health or by a health card attesting to the information prescribed in annex IX.
- Article 13. Bees, honey and beeswax for trade between the two Contracting Parties shall be accompanied by a certificate of origin and health conforming to the model in annex X.
- Article 14. Fish, embryonated fish roe and aquatic animals intended for continental waters shall be accompanied by a certificate of origin and health that attests to the information prescribed in annex XI.

Article 15. Meat, meat products and other products of animal origin shall be accompanied by a certificate of origin and health conforming to the model drawn up and approved by the Contracting Parties in annex XII.

Article 16. The Contracting Parties shall exchange annually a list of slaughterhouses and meat-processing plants licensed to export by the State. These industrial establishments may be inspected by veterinarians of the importing country.

Any changes in this list shall be communicated to the other country concerned.

Article 17. All slaughterhouses and processing plants handling meat for export shall use a single identification number which shall be stamped on the meat and on all wrappings, tags, packing and documents accompanying shipments.

Article 18. In general, handlers and workers suffering from a contagious disease or liable to be disease carriers shall not be allowed to work in slaughterhouses and other meat-processing plants.

The personnel of such establishments shall undergo such medical examinations as may be required by the public health authorities of each country, and the results thereof shall be entered in their individual health records.

Article 19. Slaughterhouses licensed to export shall be equipped with at least the following facilities:

- Holding pens to let the animals rest;
- A suspect pen for observation and isolation;
- An area for slaughtering cattle;
- An area for slaughtering sheep:
- An area for slaughtering pigs;
- An area especially set aside for slaughtering diseased animals or animals whose health is suspect (health inspection section catch pen);
- Gut-dressing and tripe-dressing works;
- Refrigeration facilities for meat and offal;
- Facilities for the disposal or industrial utilization of waste products and condemned products, or containers for such products meeting the requirements for their transport and possible utilization by other industries;
- Agents for disinfecting vehicles and utensils.

All these facilities shall operate under veterinary control and shall comply with strict technical and sanitary regulations.

Slaughterhouses licensed to export shall be set up so that the operations of slaughtering and dressing are carried out with the animal suspended (except for the dehairing of pigs).

Article 20. All carcasses other than those of pigs shall be skinned before evisceration.

Article 21. No cuts or incisions on the meat shall be permitted other than those which were made when the meat was dressed. Muscle surfaces and serous

membranes must be in their normal state, so that they can be examined as required by the offical veterinary services.

Export shall be prohibited of all meat that comes from animals whose fattening was stimulated by substances not authorized under the regulations of the importing country.

Article 22. Fresh meat, whether frozen or not, shall be presented for import only in the following forms:

- Beef: sides, quarters, "pistol-quarters", or boned cuts;
- Pork: sides, hams, bladebones, and boned or unboned cuts;
- Horsemeat: boned or unboned quarters:
- Lamb: whole carcasses:
- Mutton: whole carcasses:
- Boned cuts shall always be easily identifiable;
- Tongue, heart, liver, kidneys and brains: whole;
- Stomach, entire intestines: cleaned, scalded and bleached.

The official veterinary services of the Contracting Parties shall have the right to approve meat imported in other forms which may emerge in future as a result of new requirements or new meat-processing techniques.

Article 23. Stamps shall be officially approved.

Each quarter shall bear at least two veterinary-inspection stamps.

Lamb and mutton carcasses shall bear at least two stamps, one on each side.

Every side of pork shall bear at least two stamps.

Individual cuts of meat shall be stamped, unless several cuts are packed together and the packing is duly stamped.

Every package of meat cuts or of intestines shall bear a tag indicating the name and address of the slaughterhouses which supplied it, the date of slaughter or processing and the word "export". The tag shall bear an inspection stamp and the date of inspection. A duplicate of this tag shall be placed inside each package.

The inspection stamp on the meat and tags shall also be applied on the certificates issued by the official veterinary services, thus attesting to the fact that the products have undergone veterinary inspection in accordance with the health and veterinary health legislation of the Contracting Parties.

Article 24. The stamp of the plant of origin shall be applied on containers, wrapping and packing and shall signify that the packing was done by the plant itself.

The name, number and address of the cutting and processing plant shall be legibly stamped on each package. A duplicate of the stamp shall be placed inside each package.

Article 25. With regard to industrial plants. Meat-boning and meatprocessing plants licensed to export shall maintain the highest hygienic standards in all their operations and work areas. They shall be equipped with:

- A meat-warehousing area, equipped with adequate refrigeration facilities for raw materials;
- A meat-cutting area;
- A fabricating area for processing meat products;
- A packaging and labelling area;
- A storage and shipping area with refrigeration facilities.

The cutting area and related facilities (for boning and dividing into smaller cuts) shall be equipped with air-conditioning for maintaining a maximum temperature of 12 degrees centigrade, and with containers for the hygienic collection of waste products.

The boning and processing plants shall use only meat from slaughterhouses licensed to export.

The use of antibiotics, antioxidants and the like shall be prohibited in meat-processing plants, in accordance with the regulations of the respective countries.

Article 26. Whole fowl shall be defeathered, with heads and feet removed, and eviscerated, in accordance with the veterinary requirements of the importing country.

Fowl in parts, refrigerated or frozen, shall be protected by a water-tight wrapping of hygienic material.

Each shipment shall be accompanied by a veterinary health certificate attesting to the origin and fitness for consumption of the meat in the shipment.

- Article 27. Game and game by-products shall come solely from the territory of either of the Contracting Parties, be prepared for export according to the requirements of the importing country and be accompanied by a certificate of origin and of fitness for consumption conforming to the model in annex XIII.
- Article 28. Products for export, of either animal or vegetable origin and intended as food for livestock, including meat flour, blood flour, bone flour and other raw materials used for compounding livestock feeds, and also products intended for industrial processing such as wool, hair, fur, hides, feet, hoofs, horns, intestines, offal and the like, shall be accompanied by a certificate of origin and health issued by an official veterinarian and conforming to the model in annex XIV.
- Article 29. 1. Where the official veterinary services of the importing country detect symptoms of any contagious disease in animals for export, they shall be entitled to act in accordance with the laws of their country governing such a situation and to communicate the results of their examination to the authorities of the exporting country.

Depending on the nature of the disease, the measures to be taken may or may not apply to all the animals in the same consignment or coming from the same place.

2. The veterinary inspection services of the importing country must state, in a document or certificate issued expressly for the purpose, the grounds for quarantining or slaughtering the animals from which action no right shall derive for the exporting country.

3. Where unmistakable symptoms of infectious disease are detected in a consignment of imported animals once they have reached their destination, an official veterinarian shall draw up a report.

Where the restrictive measures referred to in this article are taken, the official veterinary services of the importing country must immediately notify the veterinary services of the exporting country by telegram of, *inter alia*, the animals affected by the health decisions and the nature of the measures taken. A bilateral veterinary committee shall be set up for the purpose of reviewing the facts and determining the measures or rules to be applied.

- Article 30. 1. The provisions of this Agreement shall also cover animals that come from the territory of one of the Contracting Parties and are in transit through the territory of the other Party. Prior authorization shall be required for transit through the territory of third countries.
- 2. Fresh, frozen or processed meat of whatever kind, as also products of animal origin, which are being transported from the territory of one of the Contracting Parties and are in transit through the territory of the other Party, whether by train or road, in railway wagons or lorries, in sealed and marked shipments, or by sea or air, shall be allowed entry without a request on the part of the importing country for prior authorization from the authorities of that other Party.
- Article 31. Each of the Contracting Parties undertakes to publish and send to the other Party every two weeks a bulletin providing information on the status of epizootic diseases.

In addition, each of the two countries must be informed of the occurrence of contagious and exotic diseases and must, in such cases, receive a complete list of the infected localities specifying the region or province.

If extremely virulent infectious diseases, such as rinderpest, contagious pleuropneumonia, foot-and-mouth disease caused by an exotic virus, African horse sickness or African swine fever, occur in the territory of one of the Contracting Parties, its central veterinary services must immediately alert the corresponding services of the other Party by telegram. In the case of foot-and-mouth disease, the type of virus isolated shall be reported.

In such cases, the importing country shall be entitled to halt or limit the import or transit of animals and products of animal origin and also of articles used in such trade which might be liable to transmit the diseases. Similarly, when extremely virulent infectious diseases that make such security measures advisable occur in the other country or in countries of transit, such measures may be extended for as long a period as necessary to eliminate any risk of spreading the diseases, and decisions to take such measures shall be communicated to the authorities of that other country. However, the other provisions of this Agreement must also be taken into account.

- Article 32. The documentation pertaining to implementation of this Agreement may be amended by direct communication between the central veterinary services of the two Contracting Parties.
- Article 33. Vehicles used for transporting animals or products of animal origin shall be disinfected in accordance with the regulations in force in each of the countries, provided those regulations are recognized as valid by the other Contracting Party.

- Article 34. In order to facilitate implementation of this Agreement and to consider possible amendments thereto, a Joint Veterinary Commission shall be established, consisting of three representatives of each Contracting Party to be appointed by the respective Ministries of Agriculture. The Commission shall meet annually, alternately in the territory of each of the Contracting Parties, and its functions shall be:
- (a) To review the implementation of this Agreement and propose to the respective Governments possible steps for ensuring the most effective application of its provisions;
- (b) To submit for the approval of the respective Governments proposals regarding amendments to the provisions of this Agreement;
- (c) To seek solutions for settling disputes concerning the implementation and interpretation of this Agreement;
- (d) To submit to the respective Governments, with a view to co-operation in matters relevant to this Agreement, proposals based on recommendations from international bodies recognized as competent by both Governments.
- Article 35. Recognizing the usefulness and necessity of close co-operation between the veterinary services of both Contracting Parties, and the consequent advantages to be derived from exchanges of theoretical and practical knowledge in the field of veterinary science, the two signatory Governments shall make arrangements for exchanging specialists and communications in the manner to be established by the central veterinary services of the two countries.
- Article 36. This Agreement shall enter into force 30 days after the date on which the two Parties have notified each other through the diplomatic channel that the requisite domestic constitutional procedures for its entry into force have been completed.

This Agreement shall remain in force for five years and shall be automatically renewed for successive five-year periods, unless one of the Contracting Parties denounces it in writing at least six months before the expiry of any such period.

- 2. That the animal, having been inspected the day before shipment, does not show any clinical sign of infectious, contagious or parasitic disease;
- 3. That the farm from which the animal comes:
 Is free of tuberculosis, brucellosis and foot-and-mouth disease and that, during the
 12 months prior to export, no case of bovine leptospirosis, bovine leucosis, bovine
 trichomoniasis or any other disease specified in lists A and B of the International Office
 of Epizootics (OIE) has been diagnosed;
- 4. That the animal, in the case only of females, does not show any clinical sign of mastitis on the day of shipment;
- 5. That the animal to be exported has, within the 30 days prior to the date of shipment, undergone the following tests, carried out by an official laboratory, the results being negative:

- (a) For tuberculosis: intradermal tuberculin test;
- (b) For brucellosis: seroagglutination test at a dilution of 1:25 (less than 30 IU per ml or, in the case of vaccinated animals, less than 50 IU), and a complement-fixation test;
- (c) For leptospirosis: seroagglutination lysis test evidencing titres of less than 1:400 for all types of Leptospira;
- (d) For leucosis: blood test (only for animals over 30 months);
- (e) For mastitis (in the case only of milk cows): bacteriological milk test (White Side Test (W.S.T.) or California Mastitis Test (C.M.T.));
- 6. That the animal has been vaccinated against foot-and-mouth disease with trivalent OAC vaccine, no less than 15 days and no more than three months prior to shipment;
- 7. That the country has been free from rinderpest and contagious bovine pleuropneumonia for the last 12 months.

- 6. That the animal has been kept under veterinary observation for 21 days prior to export and has shown no clinical sign indicative of a contagious disease.
