EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹
BETWEEN THE GOVERNMENT OF DENMARK AND THE
GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA
CONCERNING A PROJECT UNIT IN THE MINISTRY OF
NATIONAL EDUCATION

Sir,

With reference to the request from the Ministry of Finance and Planning concerning Danish technical assistance towards the Project Unit in the Ministry of National Education, I have the honour to inform you that the Government of Denmark will endeavour to recruit experts for the Unit totalling 22 man years and further grant 1,1 million DKr towards transportation and equipment under the following conditions:

1. The objective will be to assist the Ministry of National Education in planning and executing the programme of building and construction for educational purposes by placing in the Project Unit suitable technical experts and to equip the Unit with transportation facilities including maintenance and running cost of the vehicles.

2. The Government of Denmark is prepared to:

- a. Recruit and pay salaries, international travel expenses and insurance for a total of 22 man years;
- b. Finance within a budget of DKr 1,1 million the purchase of 4-wheel drive vehicles and equipment for the use of experts, including running cost and maintenance.

3. The Government of Tanzania will undertake to:

- a. Recruit suitable counterparts for the experts on a one to one basis;
- b. Ensure that the rights and privileges of the experts and their dependants are in conformity with the provisions of the Danish-Tanzanian agreement on Scientific and Technical Co-operation signed in Dar es Salaam on April 5, 1967;²
- c. Exempt the vehicles and equipment including spare parts from import duties, fiscal levies, sales taxes, etc., or pay such charges itself.

If the foregoing is acceptable to the Government of Tanzania, I have the honour to suggest that this letter and your reply shall constitute an agreement between our two Governments on this matter.

Please accept, Sir, the assurances of my highest consideration.
