#### AGREEMENT' ON ECONOMIC, SCIENTIFIC, CULTURAL AND TECHNICAL CO-OPERATION BETWEEN THE GOVERN-MENT OF THE HELLENIC REPUBLIC AND THE GOVERN-MENT OF THE KINGDOM OF MOROCCO

The Government of the Hellenic Republic and the Government of the Kingdom of Morocco, bearing in mind the friendly relations that already exist between the two countries and their people,

Desiring to promote still closer relations on the basis of equality and mutual benefit,

Recognizing the advantage for both countries of closer co-operation in the economic, scientific, cultural and technical fields,

Have agreed as follows:

*Article 1.* The Contracting Parties shall seek to promote economic, scientific, cultural and technical co-operation between the two countries in areas likely to contribute to the development of their economies.

Article 2. Economic and technical co-operation between the two countries shall in general extend to trade, industry, tourism, transport and communications, public works, shipping, shipbuilding, fishing and any other area approved by the Contracting Parties, taking into account the mutual advantages involved and the capabilities of each of the two Parties.

Article 3. The Contracting Parties shall take all possible steps needed to promote cultural, scientific and technical co-operation between the two countries in education and the training of managerial staff, in the exchange of specialized personnel and technical experts and in the exchange of scientific and technical information in various fields.

Article 4. The Contracting Parties shall, if necessary, conclude specific agreements, on the basis of this Agreement, concerning co-operation referred to in the preceding articles.

Article 5. The Contracting Parties shall encourage economic, scientific, cultural and technical co-operation between nationals and agencies of the two countries, in accordance with the laws and regulations in force in the two countries.

Article 6. In order to facilitate the application of this Agreement and promote closer economic, scientific, cultural and technical co-operation between the two countries, the Contracting Parties agree to establish a Joint Commission composed of representatives of the two Governments.

The Joint Commission shall meet at least once a year alternately in Greece and in Morocco.

Article 7. This Agreement shall enter into force on the date of signature. It shall be valid for a period of five years from the date of its entry into force.

Upon expiry of that period, it shall be automatically renewed for a subsequent five-year period unless either of the Parties notifies in writing, with six months' notice, its intention of terminating it.

Termination of this Agreement shall not automatically terminate the specific agreements referred to in article 4 above, unless so specified in the notification of termination.

IN WITNESS WHEREOF the undersigned, duly authorized by their respective Governments, have signed this Agreement.
