LONG-TERM PROGRAMME 1 FOR THE STRENGTHENING OF ECONOMIC AND INDUSTRIAL CO-OPERATION BE-TWEEN THE USSR AND ITALY

In accordance with the Agreement between the Government of the Union of Soviet Socialist Republics and the Government of the Italian Republic on the development of economic, industrial and technical co-operation, concluded on 25 July 1974, the Parties have formulated the following Long-term Programme.

The Programme shall contribute to the practical realization of the principles and purposes of the Agreement. A particular aim is the improved utilization, in the interests of both Parties, of the raw materials, energy resources, technology, equipment and consumer goods of the two countries.

In accordance with the Agreement, and to the best of their ability, the Parties shall encourage the participation of appropriate organizations, enterprises and firms in the execution of specific projects in the field of economic and industrial co-operation.

CO-OPERATION IN THE CONSTRUCTION OF INDUSTRIAL COMPLEXES IN THE USSR AND IN ITALY, AND ALSO IN THE MODERNIZATION AND EX-PANSION OF EXISTING ENTERPRISES

The Parties consider that the participation of organizations, enterprises, firms and banks of one country in the planning and construction of industrial complexes and in the modernization and expansion of existing enterprises of the other country is an important form of economic and industrial cooperation with a view to the improved utilization of their economic and industrial potential.

The Parties proceed from the assumption that the equipment and technological processes involved will be in keeping with the latest technological advances and will be offered on competitive terms.

In so far as possible, the Parties shall endeavour to facilitate the conclusion of contracts relating to the aforesaid projects, and in particular to large-scale projects.

In implementing such projects and having regard to the particular importance of certain projects, both Parties shall take measures under this Programme to ensure that any deliveries on a delayed-payment basis are subject to the most favourable possible credit terms in the context of the pertinent regulations in force in the two countries.

2. CO-OPERATION IN THE CONSTRUCTION OF INDUSTRIAL ENTERPRISES IN THE USSR ON A COUNTER-TRADE BASIS

The two Parties recognize that there are significant opportunities for the participation of Italian firms in the construction of industrial enterprises in the USSR, including enterprises for the extraction and processing of raw materials, on a counter-trade basis.

Such co-operation may involve deliveries by Italian firms, possibly on a delayed-payment basis, of complete sets of equipment, materials, technical documentation and know-how, payment for which may be made in full or in part in the form of deliveries of products from these enterprises which are advantageous for the Italian economy.

Deliveries of such products may continue, if the arrangement is of mutual interest, even after the repayment of credits, on the basis of contracts between interested organizations and firms.

A list of possible co-operation projects in this field is given in annex 2.

3. Development of industrial co-operation between Soviet and Italian organizations and firms, including joint production

The Parties consider that the development of industrial co-operation and the joint production of goods designed to meet the needs of the USSR and Italy can play an important role in strengthening Soviet-Italian co-operation.

The Parties note that sectoral Soviet-Italian working groups can be of considerable assistance in identifying co-operation projects in the area of industrial collaboration, including joint production.

A list of possible co-operation projects in this field given in annex 3.

4. Prospects for expanding the reciprocal exchange of goods and services

The Parties consider that the practical implementation of this Programme will create favourable conditions for developing exchanges of goods between the two countries and improving the structure of such exchanges, and also for achieving greater equilibrium in the trade balances of the two countries.

Together with an overall increase in the trade turnover between the two countries, the Parties shall, within the framework of the legislation in force, encourage initiatives to promote increased deliveries, on competitive terms, from the USSR to Italy of various types of finished industrial products, including machinery and equipment, in addition to traditional export items, the sale of licences and patents for modern technology, and also increased deliveries from Italy to the USSR of machinery and equipment, iron and steel products, chemical products and consumer goods.

The Parties also consider it desirable, if the arrangement is of mutual interest, to make wider use of the practice of concluding long-term contracts for the supply of goods and services where appropriate.

Annex 4 contains an illustrative list of goods for which prospects for a further expansion of trade may exist.

This Programme is in the nature of a recommendation for organizations, enterprises and firms of the two countries which are involved in the practical realization of economic and industrial co-operation. Such co-operation shall be effected through the conclusion of agreements and contracts between the competent Soviet organizations and Italian enterprises and firms in accordance with the laws and regulations in force in each country.

The Parties have agreed to assist in the conclusion of agreements and contracts to the best of their ability. The implementation of the co-operation projects provided for in this Programme may be effected on the basis of mutual agreements, involving either cash payments or credit, including commercial credits.

The Parties have agreed that the procedure and conditions for the provision of credits and financing considered necessary for the execution of individual co-operation projects included in this Programme shall be determined in special financing agreements between the two Parties.

Such agreements shall, in particular, determine the amount of the credit, its duration, the rate of interest, the currency of payment, the minimum amount involved in the contract and the proportion to be paid in cash, in the case of contracts for which such credit may be used.

In accordance with the aforesaid financial agreements, individual cooperation contracts shall be negotiated by the Soviet foreign trade organizations and the Italian enterprises and firms, in accordance with the laws and regulations in force in the two countries.

The Parties shall pay particular attention to the consideration of projects to be implemented on a counter-trade basis taking account of the effects which the implementation of these projects may have for the economies of both countries.

This Programme does not exhaust all possible fields and subjects of co-operation between the two countries. In the course of implementation of the measures envisaged therein, the Programme shall be defined in greater detail and supplemented by agreement between the two Parties, in the light of any new needs and possibilities that may arise.

The Parties shall meet, as a rule, at least twice a year in order to review the progress made in the implementation of the Programme to exchange the necessary information and formulate suitable measures.

PROTOCOL¹ TO THE LONG-TERM PROGRAMME FOR THE STRENGTHENING OF ECONOMIC AND INDUSTRIAL CO-OPERATION BETWEEN THE USSR AND ITALY²

The Government of the Union of Soviet Socialist Republics and the Government of the Italian Republic,

Referring to the provisions of the Agreement on the development of economic, industrial and technical co-operation of 25 July 1974,³ and of the Long-term Programme for the strengthening of economic and industrial co-operation of 29 October 1975,²

Noting with satisfaction the significant progress made in the field of economic co-operation between the USSR and Italy,

Confirming their desire, in keeping with the principles and all the provisions contained in the Final Act of the Conference on Security and Cooperation in Europe, signed at Helsinki on 1 August 1975, 4 to develop and further strengthen their mutually advantageous economic co-operation,

Have noted and agreed upon the following:

- 1. As a result of the measures taken by both Parties, the Long-term Programme for the strengthening of economic and industrial co-operation of 29 October 1975 is being successfully implemented and is contributing to the expansion of economic relations between the USSR and Italy on a long-term basis.
- 2. With regard to the participation of Italian firms in the construction of industrial facilities in the USSR, contracts have been concluded between Soviet foreign trade organizations and Italian firms for the supply of equipment, in particular for the Kama automobile complex for the chemical, petrochemical and gas industries, for the light industry and the food industry sectors, and for other industrial sectors.

With regard to the participation of Soviet organizations in the construction of industrial facilities in Italy, the two Parties have agreed to pursue their efforts and to seek new possibilities in that direction.

With a view to expanding these forms of co-operation, the two Parties have agreed to supplement the Long-term Programme with the projects listed under items A and B of the annex to this Protocol.

3. The two Parties have noted the significant development of bilateral long-term economic co-operation in the construction of industrial enterprises on counter-trade basis in the USSR.

In this area a number of important agreements and contracts have been concluded between Soviet foreign trade organizations and Italian firms, in particular for deliveries of Soviet natural gas to Italy and for deliveries to the USSR of equipment, pipes and materials for the gas industry and for the construction of gas pipelines, and for deliveries of equipment for the production of carbamide, acrylonitrile, chlorofluoromethanes, caustic soda, chlorine, metal anodes, toluene caprolactam, and polypropylene.

With a view to further expanding this form of co-operation, the Parties envisage the possibility of co-operation, supplementary to the Long-term Programme, in the construction of enterprises in the USSR in the chemical. petrochemical and oil-refining sectors involving deliveries of machinery, licences and technical documentation.

- 4. The two Parties have reaffirmed their willingness to do their utmost to facilitate the contract of negotiations between competent Soviet organizations and Italian firms on the industrial co-operation projects specified in annex 3 to the Long-term Programme.
- 5. Co-operation on the projects listed in the annex to this Protocol shall be carried out in accordance with the provisions of the Agreement of 25 July 1974 and the Long-term Programme of 29 October 1975.
- 6. This Protocol constitutes an integral part of the Long-term Programme signed on 29 October 1975.
