AGREEMENT' BETWEEN THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES AND THE GOVERNMENT OF THE KING-DOM OF THAILAND ON AGRICULTURAL COOPERATION

The Government of the Republic of the Philippines and the Government of the Kingdom of Thailand,

Desirous of developing agricultural cooperation,

And desirous of further strengthening the friendly relations between the two countries,

Do hereby agree as follows:

Article I. 1. There shall be constituted a committee at the ministerial level (hereinafter referred to as "the Ministerial Committee") consisting of the Minister of Agriculture of the Philippines and the Minister of Agriculture and Cooperatives of Thailand and Senior Officials of the Governments of the Republic of the Philippines and the Kingdom of Thailand.

2. The Ministerial Committee shall formulate and submit recommendations to the respective Governments with a view to promoting the agricultural development of both countries and, to this end, may from time to time decide on:

- (i) The policy, substance and procedural matters to be adopted by the sub-committee referred to in article II; and
- (ii) The functions of any *ad hoc* committee which may be constituted by the Ministerial Committee.

3. The Ministerial Committee shall meet at least once a year alternately in the Philippines and Thailand. At each meeting of the Committee, the Chief Representative of the host country shall be Chairman. The prospective Chairman of each proposed meeting shall decide upon the venue in his country.

Article II. 1. There shall be constituted sub-committees as specified in annexure I to this Agreement and such other sub-committees as may be agreed upon by the Ministerial Committee. The composition of those sub-committees are as specified in annexure II.

2. The sub-committee shall deal with all matters related to their respective areas and shall submit proposals to the Ministerial Committee.

3. The sub-committee shall meet at least once a year alternately in the Philippines and Thailand or as often as required at places to be mutually agreed upon.

4. At each meeting of the sub-committee, the Chief Representative of the host country shall be Chairman.

Article III. All matters for the consideration of the Ministerial Committee shall be submitted through diplomatic channels.

Article IV. This Agreement and its annexures may be amended at any time by mutual agreement between the two Governments on the recommendation of the Ministerial Committee.

Article V. This Agreement shall come into force on the date of its signature by the duly authorized representatives of the Government of the Republic of the Philippines and the Government of the Kingdom of Thailand.

Article VI. This Agreement may be terminated at any time by means of a written notification by one party to the other and such termination shall take effect on the expiration of a period of three months from the date of the said notification.
