AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE UNITED STATES OF AMERICA AND THE GOVERNMENT OF THE SOCIALIST FEDERAL REPUBLIC OF YUGOSLAVIA ON THE ESTABLISHMENT OF A UNITED STATES INFORMATION CENTER IN TITOGRAD IN ACCORDANCE WITH THE TERMS OF THE MEMORANDUM OF UNDERSTANDING OF 14 JUNE 1961²

The Government of the United States of America and the Government of the Socialist Federal Republic of Yugoslavia, in conformity with the provisions of Paragraph 1 of the Memorandum of Understanding between the United States of America and the Federal People's Republic of Yugoslavia Regulating the Operations of the American Reading Rooms, signed in Belgrade on 14 June 1961,² have agreed as follows:

Article 1. The Yugoslav Government shall permit the establishment of a United States Information Center in Titograd, which will perform its activity under the name of "American Information Center in Titograd".

Article 2. The American Information Center in Titograd shall inform the Yugoslav public about events and developments in the United States and shall perform its activity under the provisions set forth by the Memorandum of Understanding between the United States of America and the Federal People's Republic of Yugoslavia Regulating the Operation of the American Reading Rooms, signed in Belgrade on 14 June 1961.

Article 3. The Government of the United States of America will permit the establishment of Yugoslav Information Centers in the United States of America as may be agreed upon between the two governments, which will have as a goal informing the public of the United States of America about events and developments in the Socialist Federal Republic of Yugoslavia.

With respect to rights and duties, any Yugoslav Information Center established in the United States will be accorded by the Government of the United States of America rights and privileges on a basis of reciprocity and in accordance with applicable laws and regulations in effect in the United States of America.

Article 4. This Agreement shall enter into force upon its acceptance by authorized parties of both countries in accordance with their national laws.

This Agreement shall remain in force indefinitely unless six months notification in writing is given by either party to the other of its decision to terminate the Agreement.

SIGNED in Belgrade on 25 June 1979 in duplicate in the English and Croato-Serbian languages, both texts being equally authentic.
