EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF AUSTRALIA AND THE ASIAN DEVELOPMENT BANK CONCERNING THE TRANS-FER TO THE BANK OF THE CONTRIBUTION OF THE GOV-ERNMENT OF AUSTRALIA TO THE MULTI-PURPOSE SPECIAL FUND

Dear Mr. Yoshida,

I refer to the contribution of \$A8,705,000 which the Bank received from the Government of Australia under an Agreement made on 3 December 1970 (the Contribution Agreement) and which is at present being administered in the Bank's Multi-Purpose Special Fund.

I am aware of the objective of the Bank to consolidate in the Asian Development Fund, as soon as possible, all contributions originally made available to the Multi-Purpose Special Fund. The Government of Australia is ready to concur in the transfer to the Asian Development Fund of the contribution mentioned in the preceding paragraph. I propose that such transfer be carried out in accordance with the following conditions:

- (i) All resources contributed by the Australian Government to the Multi-Purpose Special Fund and currently being administered by the Bank in such Fund, including amounts of such resources drawn down under loans (all such resources being hereinafter called "The Contribution"), shall forthwith be transferred to the Asian Development Fund, and shall be consolidated with the resources contributed by Australia direct to the Asian Development Fund; and
- (ii) As from the date such transfer occurs, the Contribution shall be governed by the regulations of the Asian Development Fund to the same extent as if it had been contributed direct to the Asian Development Fund, and the provisions of the Contribution Agreement shall no longer apply thereto; amounts received by the Bank in respect of the Contribution immediately prior to transfer shall become receivables of the Asian Development Fund; income accruing on the Contribution after transfer shall accrue as income of the Asian Development Fund.

I would propose that this letter and your reply to the effect that the arrangements set forth herein are acceptable to the Bank constitute an agreement between
