Excellency:

I have the honor to refer to recent discussions between our two Governments concerning the approximately 560 U.S. military personnel expected to arrive in Egypt beginning on or about June 15, 1980, in connection with the joint Egyptian-United States Air Force training exercise announced on June 12, 1980. In order to provide for the legal status of these personnel while in Egypt, I propose that pending the negotiation of a comprehensive agreement between our two Governments on the legal status of various categories of U.S. military personnel and accompanying civilian personnel in Egypt, they be accorded the same privileges, immunities and treatment as provided to the special United States Force assigned to the clearance of mines and unexploded ordnance from the Suez Canal under the exchange of notes dated April 13 and 25, 1974, as amended.²

If the foregoing is acceptable to the Government of the Arab Republic of Egypt, I have the honor to propose that this note and your note in reply confirming acceptance will constitute an agreement between our respective Governments effective from the date of first arrival of these U.S. military personnel in Egypt.
