AGREEMENT' BETWEEN THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY AND THE GOVERNMENT OF THE REPUBLIC OF CHAD CONCERNING FINANCIAL CO-OPERATION

The Government of the Federal Republic of Germany and the Government of the Republic of Chad,

In the spirit of the friendly relations existing between the Federal Republic of Germany and the Republic of Chad,

Desiring to strengthen and enhance these friendly relations through financial cooperation as partners,

Aware that the maintenance of these relations constitutes the basis for the present Agreement,

Intending to contribute to social and economic development in the Republic of Chad,

Have agreed as follows:

- Article 1. The Government of the Federal Republic of Germany shall enable the Government of the Republic of Chad to obtain from the Kreditanstalt für Wiederaufbau (Reconstruction Loan Corporation), Frankfurt am Main, for the financing of the foreign exchange costs arising from the supply of goods and services to cover necessary current civilian requirements and the transport, insurance and assembly incurred in connection with imports of goods so financed, a financial contribution of up to DM 5 million (five million deutsche mark). The said costs must relate to deliveries and services covered by the list annexed to this Agreement and for which shipping documents were issued after the signature of the financing contract to be concluded in accordance with article 2.
- Article 2. Utilization of the financial contribution as well as the terms and conditions on which it is granted shall be governed by the contracts to be concluded between the Government of the Republic of Chad and the Kreditanstalt für Wiederaufbau; that contract shall be subject to the legal provisions applicable in the Federal Republic of Germany.
- Article 3. The Government of the Republic of Chad shall exempt the Kredit-anstalt für Wiederaufbau from all taxes and other fiscal charges levied in the Republic of Chad at the time of the conclusion or execution of the contract referred to in article 2 above.
- Article 4. The Government of the Republic of Chad shall allow passengers and suppliers free choice of transport enterprises for such transportation of passengers and goods by sea and air as results from the granting of the financial contribution, refrain from taking any measures that might exclude or impede the participation on equal terms of transports enterprises having their place of business in

the German area of application of this Agreement and grant the relevant permits that may be necessary for the participation of such transport enterprises.

- Article 5. With regard to deliveries and services resulting from the granting of the financial contribution, the Government of the Federal Republic of Germany attaches particular importance to preference being given to the economic opportunities provided by Land Berlin.
- Article 6. With the exception of those provisions of article 4 which refer to air transport, this Agreement shall also apply to Land Berlin provided that the Government of the Federal Republic of Germany does not make a declaration to the contrary to the Government of the Republic of Chad within three months after the entry into force of this Agreement.
  - Article 7. This Agreement shall enter into force on the date of its signature.

DONE at Bonn on 24 August 1978, in duplicate in the German and French languages, both texts being equally authentic.

### ANNEX TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY AND THE GOVERNMENT OF THE REPUBLIC OF CHAD CONCERNING FINANCIAL CO-OPERATION

List of goods and services eligible for financing from the financial contribution up to a total value of DM 5,000,000 (five million deutsche mark) under article 1 of the intergovernmental Agreement of 24 August 1978:

- (a) Industrial raw and auxiliary materials as well as semi-manufactures,
- (b) Industrial equipment and agricultural machinery and implements,
- (c) Spare parts and accessories of all kinds,
- (d) Chemical products, in particular fertilizers, plant protection agents, pesticides, medicaments.
- (e) Other industrial products important for the development of the Republic of Chad,
- (f) Consulting services and licence fees,
- (g) Transport, insurance and installation costs incurred in connection with financed imports of goods under the loan.

Imports of goods not included in the above list may be financed only with the prior approval of the Government of the Federal Republic of Germany.

The import of consumer goods for private requirements, particularly luxury goods, and of goods and equipment for military purposes, shall be excluded from financing under the financial contribution.
