EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE NETHERLANDS AND THE GOVERNMENT OF CANADA ON THE MATTER OF FREE ENTRY-VISAS TO STUDENT EMPLOYEES

The Embassy of the Kingdom of the Netherlands presents its compliments to the Ministry of External Affairs of Canada and has the honour to inform the Ministry that the Government of the Kingdom of the Netherlands is prepared on the basis of reciprocity, to issue, free of charge, entry-visas to Canadian student employees in the field of agriculture or in a general profession.

The Embassy would appreciate it if the Ministry would confirm that the Government of Canada for its part, is prepared to act in accordance with the above mentioned reciprocal arrangement and that this note and the Ministry's reply thereto shall constitute an Agreement between the two Governments on this matter, which shall enter into force at the date of the Ministry's reply.

The Agreement shall remain in force indefinitely and be subject to termination by either Government serving six months notice on the other. As regards the Kingdom of the Netherlands the Agreement shall apply to the Kingdom in Europe only.

The Embassy of the Kingdom of the Netherlands avails itself of this opportunity to renew to the Department of External Affairs the assurances of its highest consideration.
