TRADE AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF FINLAND AND THE GOVERNMENT OF THE SOCIALIST PEOPLE'S REPUBLIC OF ALBANIA

The Government of the Republic of Finland and the Government of the Socialist People's Republic of Albania, desiring to give further impetus to trade between the two countries on an equitable and mutually advantageous basis, have agreed as follows:

Article 1. The exchange of goods and services shall be effected in accordance with the laws and regulations in force in the two countries.

The two Contracting Parties shall take appropriate measures to increase and diversify trade between them.

To this end, the Contracting Parties shall foster negotiations for the conclusion of contracts, including long-term contracts.

- Article 2. The exchange of goods and services shall be effected on the basis of contracts made by individuals and bodies corporate of the Republic of Finland and foreign-trade undertakings of the Socialist People's Republic of Albania.
- Article 3. The annexed representative list of Finnish exports (annex B) and the representative list of Albanian exports (annex A) specify products which are of particular interest to exporters of the two countries.

These lists are for purposes of information and are not restrictive in nature.

The lists may be modified at any time by an exchange of notes between the two Contracting Parties.

- Article 4. The prices of products transferred between Finnish individuals or bodies corporate and Albanian foreign-trade undertakings shall be agreed upon on the basis of the corresponding world market prices.
- Article 5. All payments arising out of contracts made by Finnish individuals or bodies corporate and Albanian foreign-trade undertakings shall be made in freely convertible currencies in accordance with the laws and foreign exchange regulations in force in the two countries.
- Article 6. The two Contracting Parties shall exempt the following items from customs and other import or export duties on condition that the articles in question are returned abroad:
- Goods and articles intended for fairs or exhibitions;
- Samples having no commercial value.

¹ Came into force on 1 February 1981, i.e., 30 days after the exchange of notes by which the Parties informed each other (on 2 January 1981) that the Agreement had been approved in the two countries in conformity with their domestic legislation, in accordance with article 9.

- Article 7. The two Contracting Parties, recognizing the importance of commercial information for the development of trade, shall foster the exchange of such information through chambers of commerce and other appropriate bodies. They shall in particular keep each other informed of laws and regulations concerning trade and shall make available other information conducive to the promotion of trade.
- Article 8. Representatives of the two Contracting Parties shall, at the request of either Party, meet alternately at Helsinki and Tirana to examine the trade situation and measures for the further development of trade.
- Article 9. This Agreement shall enter into force 30 days after the exchange of notes confirming that the Agreement has been approved in the two countries in accordance with their domestic legislation. It shall remain in force for five years and shall be continued in force automatically from year to year unless it is denounced in writing by either Contracting Party through the diplomatic channel not later than three months before its expiry.

The provisions of this Agreement shall also apply to contracts made but not executed before the expiry of the Agreement.

Article 10. This Agreement supersedes the Trade Agreement between the Republic of Finland and the People's Republic of Albania, signed at Tirana on 13 October 1975.

Done at Tirana on 10 September 1980, in duplicate in the Finnish and Albanian languages, both texts being equally authentic.
