# AGREEMENT' ON ECONOMIC CO-OPERATION BETWEEN THE UNITED MEXICAN STATES AND THE KINGDOM OF DENMARK

The Government of the United Mexican States and the Government of the Kingdom of Denmark,

Desiring to strengthen the traditional bonds of friendship between the two countries.

Motivated by the importance of broadening economic co-operation between the two countries, particularly in the areas of agriculture and industry, on the basis of equal rights and mutual advantage, and bearing in mind their different stages of development,

Have agreed as follows:

- Article I. The Parties undertake, in accordance with their legislation in force, to promote economic co-operation in all sectors of mutual interest, particularly the agricultural and industrial sectors, and between the various public and private institutions of their respective countries.
- Article II. The Contracting Parties undertake, in accordance with their legislation in force and their development plans, to adopt the most effective measures to consolidate economic co-operation in those areas which offer the most favourable prospects for their respective development needs, particularly in selected basic sectors.
- Article III. With a view to implementing this Agreement, the Parties shall promote agreements between public and private institutions of the two countries, including agreements on joint investments and semi-public companies. They shall also encourage the design and implementation of projects and research for the marketing in third States of the goods and services resulting from bilateral co-operation.
- Article IV. With a view to co-ordinating the implementation of this Agreement and ensuring optimum conditions for its application, the Parties agree to establish a Joint Commission, which shall be known as the Joint Mexican-Danish Commission on Economic Co-operation.

The Joint Commission shall be composed of representatives of the two Parties. Notification of appointments to the Commission shall be made through the diplomatic channel.

The Joint Commission shall meet alternately at Copenhagen and Mexico City, on mutually agreed dates.

Article V. This Agreement shall, for its entry into force, be subject to the legal formalities of each Contracting State. The Contracting States shall notify

each other of the completion of those formalities, and shall proceed to exchange the appropriate instruments. This Agreement shall enter into force on the date on which the exchange of those instruments takes place.

Article VI. This Agreement shall have provisional effect as from the date of signature.

Article VII. This Agreement shall remain in force for five years and shall be automatically renewed for the same duration, unless either of the Parties informs the other in writing, six months prior to the date of expiry, of its desire to terminate the Agreement. Furthermore, the Parties may denounce this Agreement at any time, by written notification. Termination shall take effect six months after receipt of notification by the other Party.

Done at Mexico City on 5 December 1980, in the Spanish and Danish languages, both texts being equally authentic.
