EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹
BETWEEN THE FRENCH REPUBLIC AND THE PEOPLE'S
REPUBLIC OF CHINA CONCERNING THE STATUS OF
OFFICIAL CHINESE FOREIGN TRADE FIRMS IN FRANCE
AND OF FRENCH FIRMS IN CHINA

Paris, April 1981

Sir.

I have the honour to inform you that the representatives of the Embassy of the People's Republic of China in France and the Ministry of Foreign Affairs of the French Republic have agreed as follows:

China shall establish in France agencies of the China National Import and Export Corporations and the China National Technical Import Corporation with a view to developing economic and trade relations between China and France. The French Government is prepared to provide, within the limits of French legislation, the facilities required by the above-mentioned representatives to establish offices in Paris and conduct their business.

For its part, the Chinese Government is prepared, in accordance with the principle of equality and mutual benefit, and within the limits of Chinese legislation, to provide the facilities required by representatives of French corporations at Beijing to establish offices and conduct their business.

Provisions relating to the representatives of the above-mentioned corporations are to be found in the annex to this letter.

This exchange of letters shall be valid for two years, after which time it may be extended if both parties so agree.

ANNEX

- 1. The permanent representatives of Chinese foreign trade corporations in Paris shall be entitled to hold renewable long-term residence permits. Permanent representatives of French corporations at Beijing shall enjoy similar conditions of residence.
- 2. Representatives of Chinese corporations may travel freely throughout French territory within the limits of French legislation currently in force. Representatives of French companies shall enjoy the privileges granted to foreigners by the Chinese authorities within the limits of regulations regarding travel within China.
- 3. Representatives of Chinese corporations may, in accordance with French law, rent or purchase real property in France. Representatives of French corporations may also, in accordance with Chinese government regulations, rent premises for the conduct of their business.
- 4. Material conditions permitting, representatives of French corporations shall have access to the same communications facilities (telex, etc.) as the representatives of Chinese corporations.
