AGREEMENT' BETWEEN THE UNITED STATES OF AMERICA AND THE EUROPEAN ECONOMIC COMMUNITY CONCERNING BEER CONTAINERS AND BEER, REACHED ON THE TOKYO ROUND OF MULTILATERAL TRADE NEGOTIATIONS

The European Community agrees to permit .35 liter beer containers (12 ounce equivalent) to enter the commerce of Member States and to circulate in intra-EC trade until 31 December 1988.

During this period, the European Community will give further consideration as to whether Council Directive 75/106/EEC can be modified to provide for permanent acceptance of .35 liter beer containers in intra-EC trade.

The above solution does not prejudice any measures which have been taken or might be introduced by the European Community or its Member States as a matter of environmental policy, provided that such measures apply in a non-discriminatory way.

The United States engages itself to maintain the present specific rate of duty on beer and not to convert these specific duties into ad valorem duties, at least as long as the European Community agrees to permit the .35 liter beer containers as stipulated in the first alinea.
