AGREEMENT' ON ECONOMIC, SCIENTIFIC, TECHNICAL AND CULTURAL CO-OPERATION BETWEEN THE GOVERNMENT OF THE FEDERATIVE REPUBLIC OF BRAZIL AND THE GOVERNMENT OF THE PEOPLE'S REPUBLIC OF THE CONGO

The Government of the Federative Republic of Brazil and

The Government of the People's Republic of the Congo,

Desiring to consolidate the ties of friendship existing between their two countries and their peoples,

Aware of the need to develop broad co-operation in furtherance of their economic, scientific, technical and cultural development,

Recognizing the advantages to be derived from closer bilateral co-operation in the economic, scientific, technical and cultural fields, on the basis of the principles of sovereignty, national independence, equal rights, reciprocity and non-interference in interal affairs,

Have agreed as follows:

- Article I. The Contracting Parties resolve to co-operate, within the limits of their capabilities, in the economic, scientific, technical and cultural fields.
- Article II. On the basis and within the framework of this Agreement, special agreements shall be concluded in the areas referred to in article I.
- Article III. 1. In order to facilitate the implementation of co-operation under this Agreement, a Joint Commission, composed of representatives of the two Governments and their experts, shall be established.
- 2. The Joint Commission shall ensure that this Agreement is applied and properly implemented and under its mandate, shall seek means of strengthening the cooperation between the two countries, especially in the commercial, scientific, technical and cultural fields.
- 3. Under its mandate, the Joint Commission shall submit its recommendations to the two Governments.
- 4. The Joint Commission shall, if necessary, establish specialized subsidiary bodies for the detailed study of specific questions.
- 5. The Joint Commission shall meet every two years, alternately in the territory of the Federative Republic of Brazil and in that of the People's Republic of the Congo. Moreover, at the request of either Contracting Party, it may meet in special session.
- Article IV. This Agreement shall enter into force on the date on which the two Contracting Parties exchange the instruments of ratification. It shall remain in force for a period of five years and shall be automatically renewed for further five-year

periods, unless one of the Parties notifies the other, through the diplomatic channel and at least six months before the date of expiry, of its decision to terminate it.

DONE at Brasília on 18 February 1981, in duplicate, in the French and Portuguese languages, both texts being equally authentic.
