EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT' BETWEEN FRANCE AND THE WESTERN EUROPEAN UNION CONCERNING THE PARTICIPATION OF THE REGU-LAR STAFF OF THE UNION IN THE VOLUNTARY SUPER-ANNUATION ASSURANCE SCHEME

Sir,

I have the honour to inform you that the Western European Union, with reference to the Agreement which it concluded with the French Government on 9 June 1958² concerning the application of French social security legislation to personnel employed by the Union, wishes the persons referred to in article 1 of that Agreement to have the right to participate in the voluntary superannuation assurance scheme under the following conditions:

Article 1. 1. Regular staff members of the Organization shall have the right, within the six-month period following their engagement by the Organization, to join the French voluntary superannuation assurance scheme.

2. Regular staff members who request to avail themselves of the provisions of paragraph 1 of this article shall be admitted to the voluntary assurance scheme as from the date of their engagement by the Organization.

3. Should a special superannuation assurance scheme be instituted for the regular staff of the Organization, the provisions of paragraphs 1 and 2 of this article shall cease to apply from the date of entry into force of such scheme.

Article 2. 1. Members of the regular staff of the Organization who are employed on the date of entry into force of this Agreement shall have the right, within a period of six months from that date, to apply for insurance under the French voluntary superannuation assurance scheme; the persons concerned shall have the right to join the scheme either as from the date on which they submit their application or as from the date of their engagement by the Organization.

2. The amount of the retroactive payments owed by the staff members to whom this article refers shall be calculated, for the entire period bought back, on the basis of the emoluments of the employment position occupied by the persons concerned on the date of their application for insurance under the voluntary scheme, within the limits of the maximum contributions applicable on the date of the application and account being taken of the contribution rates in force on that date.

3. The manner of making such payments to the competent social security institutions shall be determined directly between the competent French authorities and the Secretary-General of the Organization.

I should be grateful if you would inform me whether the above proposals meet with the approval of the Government of the French Republic. If so, I suggest that this letter and your reply should constitute an agreement between the Organization and the French Government on this point.

I should like this Agreement to enter into force on the first day of the month following the exchange of our letters. It would cease to be applicable should the Agreement of 9 June 1958 cease to be in force.
