AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE CZECHOSLOVAK SOCIALIST REPUBLIC AND THE GOVERNMENT OF SWEDEN ON CO-OPERATION IN THE FIELD OF HEALTH

The Government of the Czechoslovak Socialist Republic and the Government of Sweden, Desiring to develop their co-operation in the field of health,

Convinced that such co-operation, in accordance with the Final Act of the Conference on Security and Co-operation in Europe,² will contribute to strengthening the relations between the two countries,

Have concluded the following agreement:

Article 1. The Contracting Parties shall provide each other with information on

1. The organization of health services,
2. Principles and methods applied in the field of education and training of physicians, pharmacists, nurses and other health personnel,
3. Methods and results in the field of preventive medicine,
4. Applied methods and results in the field of public health, e. g. environmental and occupational health care, food hygiene, school health, infectious diseases control as well as disinfection, desinsection and deratisation (DDD),
5. Important results in the field of medical research,
6. Applied methods and results in the field of collecting and processing of information,
7. Methods and results in the field of health education of the population.

Article 2. The Contracting Parties will support and promote

1. Co-operation in the field of organization of health services,
2. Co-operation between medical faculties, scientific research institutes, public health institutions and medical societies,
3. The participation of experts in international congresses and scientific conferences organized by either Contracting Party,
4. The exchange of scientists, research workers, physicians, pharmacists, university teachers, teachers of specialized public health schools and other health workers.

Article 3. The Federal Ministry of Foreign Affairs of the Czechoslovak Socialist Republic and the Swedish National Board of Health and Welfare shall be responsible for the implementation of this Agreement. For that purpose the above-mentioned authorities shall prepare plans of operation, including also financial conditions.

Article 4. This Agreement enters into force upon signature and remains in force for five years. It will be automatically prolonged for further periods of five years, unless notice to terminate it is given by one of the Contracting Parties not later than six months before the expiration of a respective period of five years.
