Textes authentiques : allemand et anglais. Enregistré par la République fédérale d'Allemagne le 17 septembre 1985. AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA AND THE GOVERNMENT OF THE FEDERAL REPUBLIC OF GERMANY CONCERNING FINAN-CIAL CO-OPERATION

The Government of the United Republic of Tanzania and the Government of the Federal Republic of Germany,

In the spirit of the friendly relations existing between the United Republic of Tanzania and the Federal Republic of Germany,

Desiring to strengthen and intensify those friendly relations through financial co-operation in a spirit of partnership,

Aware that the maintenance of those relations constitutes the basis of this Agreement,

Intending to contribute to social and economic development in the United Republic of Tanzania,

Have agreed as follows:

Article 1. (1) The Government of the Federal Republic of Germany shall enable the Government of the United Republic of Tanzania to obtain from the Kreditanstalt für Wiederaufbau (Development Loan Corporation), Frankfurt/Main, a financial contribution of up to DM 20,000,000 (twenty million Deutsche Mark) for the project "Rehabilitation of plantations of the Tanzania Sisal Authority (TSA)" if, after examination, the project has been found eligible for promotion.

(2) This Agreement shall also apply if, at a later date, the Government of the Federal Republic of Germany enables the Government of the United Republic of Tanzania to obtain from the Kreditanstalt für Wiederaufbau further financial contributions for attendant measures required for the implementation and support of the project "Rehabilitation of plantations of the Tanzania Sisal Authority (TSA)".

(3) The project referred to in paragraph 1 above may be replaced by other projects if the Government of the United Republic of Tanzania and the Government of the Federal Republic of Germany so agree.

Article 2. The utilization of the amount referred to in Article 1 of this Agreement and the terms and conditions on which it is made available, as well as the procedure for awarding contracts, shall be governed by the provisions of the agreement to be concluded between the recipient of the financial contribution and the Kreditanstalt für Wiederaufbau, which agreement shall be subject to the laws and regulations applicable in the Federal Republic of Germany.

Article 3. The Government of the United Republic of Tanzania shall exempt the Kreditanstalt für Wiederaufbau from all taxes and other public charges levied in the United Republic of Tanzania in connection with the conclusion and implementation of the agreement referred to in Article 2 of the present Agreement.

The Government of the United Republic of Tanzania shall allow Article 4. passengers and suppliers free choice of transport enterprises for such transportation by sea or air of persons and goods as results from the granting of the financial contribution, abstain from taking any measures that might exclude or impair the participation on equal terms of transport enterprises having their place of business in the German area of application of this Agreement, and grant any necessary permits for the participation of such enterprises.

With regard to supplies and services resulting from the granting of Article 5. the financial contribution, the Government of the Federal Republic of Germany attaches particular importance to preferential use being made of the economic potential of Land Berlin.

Article 6. With the exception of those provisions of Article 4 which refer to air transport, this Agreement shall also apply to Land Berlin, provided that the Government of the Federal Republic of Germany does not make a contrary declaration to the Government of the United Republic of Tanzania within three months of the date of entry into force of this Agreement.

Article 7. This Agreement shall enter into force on the date of signature thereof.

DONE at Dar es Salaam on 3rd December 1984 in duplicate in the English and German languages, both texts being equally authentic.
