EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE STATE OF ISRAEL AND THE GOVERNMENT OF THE KINGDOM OF SWAZILAND ON EXTRADITION BETWEEN BOTH COUNTRIES

The Department of Foreign Affairs of the Kingdom of Swaziland presents its compliments to the Embassy of Israel and has the honour to refer to the Agreement on Extradition signed by the State of Israel and the United Kingdom on 4th April, 1960² and applied to the Kingdom of Swaziland prior to the restoration of its Independence on 6th September, 1968.

The Government of the Kingdom of Swaziland, after having examined and considered the said Agreement, has decided to accept the responsibilities and obligations of the Agreement, and shall regard it as binding between the State of Israel and the Kingdom of Swaziland.

The Department wishes to propose that this Note and a reply indicating concurrence by the Government of the State of Israel shall constitute an agreement between the two Governments in this matter.

The Department of Foreign Affairs of the Kingdom of Swaziland avails itself of this opportunity to renew to the Embassy of Israel the assurance of its highest consideration.
