AGREEMENT¹ BETWEEN THE GOVERNMENT OF ITALY AND THE UNITED NATIONS FOR THE ESTABLISHMENT AND OPERATION OF A CENTRE FOR CHILDREN IN THE ISTITUTO DEGLI INNOCENTI IN FLORENCE

Whereas the United Nations Relief and Rehabilitation Administration (“UNRRA”) and the Government of Italy (“Government”) concluded Agreements on 8 March 1945 and 19 January 1946 to carry out programmes for relief and rehabilitation in Italy and set up a special account designated as the UNRRA Lire Fund for that purpose;

Whereas the utilization of the UNRRA Lire Fund is regulated by an Agreement between UNRRA and the Government of 12 November 1947;

Whereas the United Nations has succeeded to the rights and obligations of UNRRA;

Whereas the Agreement of 12 November 1947 requires the approval of the United Nations for any changes in the allocation of the Reserve of the UNRRA Lire Fund specified in Article V (2) (e) of the Agreement;

Now, therefore, the Parties hereby agree as follows:

1. The Government and the United Nations agree to the establishment of a Centre on the premises of the Istituto degli Innocenti, Florence, for study, research, information and education in the field of assistance to children (“Centre”), to be operated by UNICEF with the co-operation of the Istituto degli Innocenti.

2. The Centre shall constitute a project within the scope of Article V (2) (e) of the Agreement of 12 November 1947.

3. The Government and UNICEF shall, by a separate Agreement, determine the terms, conditions and level of funding necessary for the establishment and operation of the Centre. The Government shall make annual allocations for the funding of the Centre.

4. Any allocations of funds for the Centre by the Government drawn from the Reserve of the UNRRA Lire Fund shall be included in the reports submitted by the Government to the United Nations under Article VIII(1) of the Agreement of 12 November 1947. Such reports shall be made annually.

5. This Agreement shall enter into force on the date of its signature.
