EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN FRANCE AND TUNISIA CONCERNING THE ADMINISTRATIVE CONDITIONS OF CERTAIN FRENCH CO-OPERATION OFFICERS

Sir,

The Embassy of France presents its compliments to the Ministry of Foreign Affairs and has the honour to inform it that a certain number of French co-operation officers performing teaching functions in Tunisia will in the near future be integrated into a division of the French civil service. In order not to penalize these officers, for whom the review of past career history and consequent grade classification will only be completed at a later time, the Embassy of France has the honour to propose to the Ministry of Foreign Affairs the following provisions:

Notwithstanding the provisions set forth in article 1 of annex I to the Franco-Tunisian Agreement of 3 March 1973,² those officers who are already serving in Tunisia and who are subject to integration into a division of the French civil service, in the event that they already have an index number higher than that which they are given upon establishment, shall, throughout the period of their service in Tunisia, retain their former index number until advancement within their grade gives them an index number that is at least equal to their former index number.

The Embassy of France would be grateful if the Ministry of Foreign Affairs would kindly inform it if the foregoing proposal is acceptable.

The Embassy of France takes this opportunity, etc.
