CO-OPERATION AGREEMENT¹ BETWEEN THE ANDEAN DEVELOPMENT CORPORATION AND THE UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION IN THE FIELD OF INDUSTRIAL DEVELOPMENT

Following consultations between Mr. Julio Sanjines, Executive President of the Andean Development Corporation (Corporación Andina de Fomento "CAF") and Dr. Abd-El Rahman Khane, Executive Director of the United Nations Industrial Development Organization the two organizations have agreed to harmonize their efforts and co-operate fully for the development of industrial programmes in the Andean region. These activities will be developed within the framework of the perspectives opened up by the Lima Declaration and Plan of Action² as well as by the policies and regulations governing the activities of both organizations.

In this connexion the following areas have been identified as offering scope for promoting joint action:

- (a) System of consultations to be carried out by UNIDO;
- (b) Technical assistance;
- (c) Promotion, preparation and evaluation of industrial investment projects;
- (d) Project implementation and factory establishment;
- (e) Assistance in the negotiation of contracts;
- (f) Promotion of industrial co-operation among developing countries;
- (g) Transfer of technology (with particular emphasis on the problems of appropriate choice of technology);
- (h) Analysis and review of industrial projects facing obstacles in their implementation, more particularly Bolivia and Ecuador;
- (i) Review and selection of industrial projects which could have an optimum impact on the economies of the member countries of CAF and which will contribute to a sub-regional equilibrium;
- (j) Participation in negotiations called for by member countries of CAF, when such consultations are not in conflict with the provisions contained in paragraphs (f) to (i);
- (k) Negotiations connected with the implementation of CAF's automotive industry programmes, as per decisions to be taken by CAF's board;
- (l) Other aspects of industrial co-operation;

Close co-ordination will be maintained between the UNIDO Senior Industrial Development Field Advisers, the UNIDO Regional Advisers and CAF's high level country representatives.

Agreement was also arrived at to hold, urgently, inter-organizational consultations and to evolve a practical basis for implementing industrial projects in the Andean region as a whole, and Bolivia and Ecuador in particular.

Following approval of the programmes, CAF will secure, with the support of UNIDO, from whatever source it has available, the necessary financing for the implementation of projects of common interest.

This Agreement will be put into operation immediately and will be submitted by the two organizations to their respective governing bodies for endorsement as early as possible.
