AGREEMENT' BETWEEN THE GOVERNMENT OF ITALY AND THE UNITED NATIONS CHILDREN'S FUND

This Agreement is made between the Government of Italy ("Government") and the United Nations Children's Fund ("UNICEF") to define the terms, conditions and funding for the establishment and operation of a Centre for study, research, information and education in the field of assistance to children, to be located on the premises of the Istituto degli Innocenti, in Florence, Italy, pursuant to clause 3 of the Agreement signed on 23 September 1986 between the Government and the United Nations.²

For these purposes, the Government and UNICEF hereby agree as follows:

- 1. UNICEF shall establish in Italy an office to be located on premises of the Istituto degli Innocenti in Florence, Italy, to be specified in agreement with the Administration of the Istituto degli Innocenti.
- 2. The UNICEF office shall have the task of establishing and operating a Centre for study, research, information and education in the field of assistance to children ("Centre").
- 3. The Government shall finance the UNICEF office and the operation of the Centre through the payment of a sum of three thousand five hundred million Italian Lire (Lit 3,500,000,000) each year for a duration of three years, in part from the Reserve of the UNRRA Lire Fund and in part as an addition to the Government's annual voluntary contribution to UNICEF.
- 4. UNICEF shall allocate the contribution indicated in paragraph 3 to meet the expenses necessary for the adaptation and use of the premises, as well as for the UNICEF office and the operation of the Centre, including the costs of the staff provided for in paragraph 7, of any expert on mission for the United Nations in connection with the office or the Centre, and of the members of the Advisory Committee referred to in paragraph 8, without any further financial contribution of the Government.
- 5. The authority and responsibility for the operation of the Centre shall be vested in UNICEF, which shall avail itself of the co-operation of the Istituto degli Innocenti.
- 6. UNICEF and the Istituto degli Innocenti shall conclude a contract, consistent with this Agreement, to regulate the use of the premises and to establish the terms and conditions for their co-operation in the operation of the Centre.
- 7. The administration of the UNICEF office and the operation of the Centre shall be entrusted to a Director designated by UNICEF, who shall be assisted by no more than six staff members appointed under the Regulations and Rules of the United Nations and thus enjoying the status of international officials. The remainder of the personnel necesary for the office and for the operation of the Centre shall be recruited or otherwise provided locally.

- 8. The Director shall be assisted on important policy matters by an Advisory Committee, consisting of four representatives of UNICEF, two representatives of the Government and two representatives of the Istituto degli Innocenti.
- 9. The privileges and immunities set forth in the Convention on the Privileges and Immunities of the United Nations, adopted by the General Assembly on 13 February 1946,' to which Italy became a party on 3 February 1958, shall apply to the UNICEF office, to its premises, assets, income and other property connected with the operation of the Centre. They shall also apply, within the limits specified for each category by the Convention, to the Director and to the staff members referred to in paragraph 7, to the representatives of UNICEF on the Advisory Committee referred to in paragraph 8 in connection with their participation in the Committee, as well as to any expert on mission for the United Nations in connection with the office or the Centre.
- 10. Any dispute between the Government and UNICEF concerning the interpretation or implementation of this Agreement which is not settled by direct negotiations or other mutually accepted methods, or pursuant to Article VIII of the Convention on the Privileges and Immunities of the United Nations, shall be referred for final decision to a tribunal of three arbitrators, one to be named by the Government, one to be named by UNICEF and the third to be chosen by those two, or, if they should fail to agree upon a third, then by the President of the International Court of Justice.
- 11. This Agreement shall enter into force the day after the exchange between the parties of an instrument of ratification by the Government and of an instrument relating to an act of formal confirmation by UNICEF on behalf of the United Nations.
- 12. This Agreement shall be in force for a term of three (3) years and may be extended by exchange of letters between the Government and UNICEF.

Rest assured that I am personally committed to seeing to it that the urgent parliamentary procedure is followed so as to ensure the speedy ratification of the Agreement, in order that the UNICEF office may become operational as soon as possible. It is also the firm intention of the Italian Government at the appropriate time to take the measures necessary to extend the life of the new centre beyond the agreed three-year period without interruption and, if possible, to increase its operational capacity on the basis of the experience acquired and the growing needs in this area.

This commitment, moreover, reflects a constant concern in the policy of the Italian Government, which has made every effort to step up and enhance the effectiveness of its cooperation with UNICEF for the attainment of their common objectives.
