# DECLARATION BY FRANCE AND MONACO CONCERNING THE DELIMITATION OF THE TERRITORIAL WATERS OF THE PRINCIPALITY OF MONACO

The Government of the French Republic and His Serene Highness the Prince of Monaco, having taken note of the report dated 3 December 1964 of the Mixed Commission established by the exchange of letters between France and Monaco of 18 May 1963,<sup>2</sup> hereby note that the territorial waters of the Principality of Monaco shall be defined as follows:

- 1. The outer limits of the territorial waters and those of the various contiguous or adjacent zones envisaged in the Geneva Convention of 29 April 1958<sup>3</sup> shall be the same as those adopted by the French Republic, with the understanding that the outermost limit of Monegasque territorial waters shall be defined by the line separating them from the high seas.
- 2. The lateral limits of the territorial waters shall be two parallel lines to be established as follows:

To the west, the prolongation of the rectilinear section closest, prior to human intervention, to the coastline of the line marking the boundary on land between the two countries. This line is indicated on land by markers bearing the letters B'1 and B, as shown on the attached diagram.<sup>4</sup>

To the east, the line parallel to the straight line defined above, running from the point where the boundary on land intersects with what was, prior to human intervention, the low-water mark: this point, shown on the attached diagram by the letter A, is represented on land by a marker bearing the letter A.

In witness whereof, the respective representatives, duly authorized for this purpose, have signed this Declaration and affixed their seals hereto.

TERMINATION OF THE DECLARATION BY FRANCE AND MONACO CONCERNING THE DELIMITATION OF THE TERRITORIAL WATERS OF THE PRINCIPALITY OF MONACO OF 20 APRIL 1967<sup>1</sup> (Note by the Secretariat)

The Government of France registered on 22 November 1985 the Convention on maritime delimitation between the Government of the French Republic and the Government of His Serene Highness the Prince of Monaco signed at Paris on 16 February 1984.<sup>2</sup>

The said Convention, which came into force on 22 August 1985, provides, in its article 5, for the termination of the above-mentioned Declaration of 20 April 1967. (4 November 1988)
