WORKING ARRANGEMENT<sup>1</sup> BETWEEN THE SECRETARIAT OF  
THE UNITED NATIONS INDUSTRIAL DEVELOPMENT  
ORGANIZATION AND THE SECRETARIAT OF THE ECONOMIC  
AND SOCIAL COMMISSION FOR ASIA AND THE PACIFIC

Co-operation and consultation

1. The Secretariat of UNIDO and the Secretariat of ESCAP agree to establish within the overall framework set forth by the Relationship Agreement between the United Nations and the UNIDO<sup>2</sup> a Working Arrangement that defines the principal areas of co-operation and the modalities to implement it.

2. In accordance with UNIDO's primary responsibility for, and its central co-ordinating role in the field of industrial development, UNIDO will assist, consult and co-operate with ESCAP, to the extent possible, to develop the industrial and technological base of the ESCAP Member States. This co-operation may apply to any field of activity within the competence and mandate of the two Secretariats.

Areas and modalities of co-operation

3. The UNIDO and the ESCAP Secretariats will exchange information on matters of common interest on a regular basis and will be invited to participate in the other

organization's meetings in accordance with the applicable provisions of Article 3 of the Relationship Agreement between the United Nations and UNIDO.

4. The two Secretariats will consult each other on ways and means to co-ordinate and co-operate in the planning and implementation of technical assistance programmes, studies, policy analyses of (industrial) trends and strategies at country, subregional and regional levels, human resources development, industrial promotion, enterprise-level co-operation and technology transfer.

5. Consultations shall take place as required in order to determine the modalities of joint activities and other forms of co-operation such as that provided through the services of the UNIDO regional advisers, experts or associate experts.

6. Communications (correspondence) between the two Organizations shall be addressed as follows:

7. This Working Arrangement shall be subject to revision by written agreement between the Secretariat of UNIDO and the Secretariat of ESCAP.
