AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE
HASHEMITE KINGDOM OF JORDAN AND THE GOVERN-
MENT OF THE FEDERAL REPUBLIC OF GERMANY CON-
CERNING FINANCIAL COOPERATION (COMMODITY AID III)

The Government of the Hashemite Kingdom of Jordan
and
the Government of the Federal Republic of Germany,

in the spirit of the friendly relations existing between the
Hashemite Kingdom of Jordan and the Federal Republic of
Germany,

desiring to strengthen and intensify those friendly relations
through financial cooperation in a spirit of partnership,

aware that the maintenance of those relations constitutes the basis
of this Agreement,

intending to contribute to social and economic development in the
Hashemite Kingdom of Jordan,

have agreed as follows:

Article 1

- (1) The Government of the Federal Republic of Germany shall enable the Government of the Hashemite Kingdom of Jordan to obtain from the Kreditanstalt für Wiederaufbau (Development Loan Corporation), Frankfurt/Main, a financial contribution of up to DM 180,000,000 (one hundred and eighty

million Deutsche Mark) to meet foreign exchange costs resulting from the purchase of goods and services to cover current civilian requirements, and to meet foreign exchange and local currency costs of transport, insurance and assembly arising in connection with the importation of goods financed under this Agreement.

The supplies and services must be such as are covered by the list annexed to this Agreement and for which bills have been issued after 2 August 1990. Supplies and services from the Republic of Iraq may not be financed from the financial contribution.

- (2) This Agreement shall also apply if, at a later date, the Government of the Federal Republic of Germany enables the Government of the Hashemite Kingdom of Jordan to obtain from the Kreditanstalt für Wiederaufbau further loans or financial contributions for the preparation of the project "Commodity Aid III" or for attendant measures required for its implementation and support.

Article 2

- (1) The utilization of the amount referred to in Article 1 of this Agreement and the terms and conditions on which it is made available, as well as the procedure for awarding contracts, shall be governed by the provisions of the agreement to be concluded between the Government of the Hashemite Kingdom of Jordan and the Kreditanstalt für Wiederaufbau, which shall be subject to the laws and regulations applicable in the Federal Republic of Germany.

- (2) The Government of the Hashemite Kingdom of Jordan shall ensure that goods and services procured with the financial contribution remain in the territory of the Hashemite Kingdom of Jordan.

Article 3

The Government of the Hashemite Kingdom of Jordan shall exempt the Kreditanstalt für Wiederaufbau from all taxes and other public charges levied in the Hashemite Kingdom of Jordan in connection with the conclusion and implementation of the agreement referred to in Article 2 of the present Agreement.

Article 4

The Government of the Hashemite Kingdom of Jordan shall allow passengers and suppliers free choice of transport enterprises for such transportation by sea or air of persons and goods as results from the granting of the financial contribution, abstain from taking any measures that might exclude or impair the participation of transport enterprises having their place of business in the Federal Republic of Germany, and grant any necessary permits for the participation of such enterprises.

Article 5

This Agreement shall enter into force on the date of signature thereof.

Annex to the Agreement of Nov.18, 1990 between the Government of the Hashemite Kingdom of Jordan and the Government of the Federal Republic of Germany concerning Financial Cooperation

1. List of goods and services eligible for financing from the financial contribution for the Commodity Aid III project under Article 1 of the Agreement of November 18, 1990:
 - (a) Industrial raw and auxiliary materials as well as semi-manufactures,
 - (b) industrial equipment as well as agricultural machinery and implements,
 - (c) spare parts and accessories of all kinds,
 - (d) chemical products, in particular fertilizers, plant protection agents, pesticides, medicaments,
 - (e) other industrial products for civilian requirements,
 - (f) advisory services, patents and licence fees.
2. Imports not included in the above list may only be financed with the prior approval of the Government of the Federal Republic of Germany.
3. The importation of luxury and consumer goods for personal needs as well as any goods and facilities serving military purposes may not be financed from the financial contribution.

4. Measures to be examined and implemented as projects or programmes may not be financed from general commodity aid.
 5. Local currency costs within the scope of commodity aid may only be assumed in respect of local transport, insurance and assembly services.
