EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES CONCERNING THE UNITED KINGDOM/PHILIPPINES DEBT RESCHEDULING AGREEMENT No. 3 (1992)

I have the honour to refer to discussions between representatives of the Government of the United Kingdom of Great Britain and Northern Ireland (hereinafter referred to as "the Government of the United Kingdom") and the Government of the Republic of the Philippines (hereinafter referred to as the "Republic of the Philippines") with regard to the terms of the Agreed Minute on the consolidation of the debt of the Republic of the Philippines signed in Paris on 20 June 1991 (hereinafter referred to as the "1991 Consolidation") concerning the Exchanges of Notes constituting the loans as follows:

United Kingdom/Philippines Loan (No. 1) 1980² and the United Kingdom/Philippines Loan (No. 2) 1980,³ as amended by the United Kingdom/Philippines Debt Rescheduling Agreement No. 1 1992⁴ and the United Kingdom/Philippines Debt Rescheduling Agreement No. 2 1992⁵ (hereinafter referred to as the "Aid Loans").

I have also the honour to refer to the Agreed Minute on the consolidation of the debt of the Republic of the Philippines signed in Paris on 20 June 1991 and to propose that, having regard to recommendations in the aforesaid Minute, the Aid Loans should be amended as set out below.

1. With regard to the terms of the 1991 Consolidation the repayment schedules of the Aid Loans in respect of those repayments of principal and interest due from 1 July 1991 up to 31 March 1993 inclusive and not paid shall be revised. Amounts equal to 100 per cent of the principal and interest due from 1 July 1991 up to 31 March 1993 shall be paid by the Republic of the Philippines in pounds sterling in London to the Government of the United Kingdom in twenty (20) equal and successive semi-annual payments. The first payment shall be made on 31 July 2002 (end of grace period) and the final payment shall be made on

31 January 2012 (end of the repayment period) as set out in Table “A” of the Annex attached hereto.

2. The Republic of the Philippines shall pay interest to the Government of the United Kingdom in pounds sterling in London on the rescheduled amounts at the rate of two per cent (2%) per annum on the amounts due under the United Kingdom/Philippines Loan No. 1 as amended by the United Kingdom/Philippines Debt Rescheduling Agreements No. 1 and No. 2 1992 as follows:

- (a) Interest shall run on each rescheduled amount from the original payment date of each such amount.
- (b) Interest shall be calculated on a day-to-day basis on the amount of the rescheduled sums outstanding.
- (c) In respect of the sums to be paid in accordance with paragraph 1 above and set out in Table “A” of the Annex attached hereto, the first instalment of accrued interest shall be payable on 31 July and subsequent payments shall be made on 31 January and 31 July of each year until all sums due have been repaid.

3. The amounts due under United Kingdom/Philippines Loan No. 2 shall continue to be free of interest.

4. The sums to be paid in accordance with paragraphs 1 and 2 above are set out in the Annex attached hereto. The Annex to this Note forms an integral part of the Note and may only be altered or amended by agreement between the Government of the United Kingdom and the Republic of the Philippines.

5. Unless otherwise amended by this Note the terms and conditions of the Aid Loans shall continue in operation. Interest payments due under the terms of the Aid Loans shall be calculated as if repayments of principal which have been rescheduled have been paid in full.

6. If the foregoing proposals are acceptable to the Government of the Republic of the Philippines, I have the honour to propose that this Note, together with its Annex, and your reply to that effect shall constitute an Agreement between our Governments in this matter, which shall enter into force and effect on the date of your reply and shall be known as the “United Kingdom/Philippines Debt Rescheduling Agreement No. 3 1992”.

I have the honour to avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
